Before today, I 11 have to make a decision based on what's happening 12 today, and I haven't seen the settlement 13 agreement or the withdrawal yet. I will see it 14 at some point, but thanks for letting me know. So I've made a note of that. 15 16 Mr. McGowan, so there will be a board 17 order that will probably go out dismissing the 18 ANC because they weren't present today. But what 19 happens next doesn't change. The board looks at 20 the settlement agreement, reviews it for 21 approval. 2.2 MR. McGOWAN: Understood. Thank you. 23 MS.
