3 CHAIRPERSON ANDERSON: All right.

4 We're now at the end of our morning agenda, and
5 so, our morning calendar, and so now we're going
6 to address our other agendas for the day starting
7 with our legal agenda.

8 All right. The first matter on our
9 legal agenda is a Review of Offer in Compromise
10 in Lieu of Hearing dated April 6, 2023, for Case
11 Number 23-CMP-00005, Alice Bar & Lounge, License
12 Number 117897. And the Offer in Compromise is as
13 follows:

14 Charge one. Playing music at such
15 intensity that it was heard in the premise of the
16 establishment, Statutory Authority D.C. Code
17 Section 257258. That charge has been dismissed.

18 Charge number two. Failed to follow
19 settlement agreement by permitting music noise or
20 vibrations to be audible outside of the
21 establishment, Statutory Authority D.C. Code
22 Section 2582386. So that charge is a fine of
23 \$500 payable within 30 days of the Board
24 accepting the Offer in Compromise. If the
25 payment is not made within 30 days, the license

1 shall be suspended indefinitely until the payment
2 has been made.

3 Is there a second?

1 This is Sound Bar, License Number 122864. And
2 the Offer in Compromise is as follows:

3 Charge one. Sale to minor, Statutory
4 Authority D.C. Code Section 25781. For that
5 term, a warning will be issued.

6 Charge two. Failed to take reasonable
7 steps necessary to ascertain legal drinking age,
8 Statutory Authority D.C. Code Section 25783. A
9 warning will also be issued for this charge.

10 Charge number three. Failed to follow
11 security plan. Statutory Authority D.C. Code
12 Section 2582386. For this charge, there's a fine
13 of \$1,000 payable within 30 days (audio
14 interference) of the Board accepting the Offer in
15 Compromise. If the payment is not made within 30
16 days, the license will be suspended indefinitely
17 until the payment is received.

18 Charge four. Failed to Post License
19 in a Conspicuous Place. Statutory Authority D.C.
20 Code Section 257011. A mandatory warning will be
21 issued for this charge.

22 I, therefore, make a motion that the
23 ABC Board approve this Offer in Compromise.
