3 CHAIRPERSON ANDERSON: Good afternoon,
4 everyone. We're on the record. Good afternoon.
5 As Chairperson of the Alcoholic Beverages - I'm
6 sorry. As Chairperson of the Alcoholic Beverage
7 and Cannabis Board for the District of Columbia
8 and accordance with D.C. Official Code Section
9 2571 et seq. of the Open Meetings Act, OMA, I am
10 welcoming you to the afternoon session of the ABC
11 Board.

12 My name is Donovan Anderson. I'm
13 Chairman of the Board. Joining me this afternoon
14 are five additional Board members, Mr. James
15 Short, Ms. Rafi Crockett, Mr. Bobby Cato, Ms.
16 Jeni Hansen, Mr. Edward Grandis.

17 The Board has six members for the
18 attendance this afternoon. This means that we
19 have a quorum, so for the operation of the ABC
20 Board, we only require three members for us to
21 have a quorum.

24 is called, I will take a minute for our IT
25 specialist to elevate the rights of each party to

7 parties will have the option to leave. If the
8 party chooses to stay, all cameras and
9 microphones for the concluded case will be
10 disabled.
