3 MS. FLETCHER: I'm going to move on to
4 the next case on the calendar, which is Mood
5 Swings Food Hall, case number 24-PRO-00026. Mood
6 Swings Food Hall LLC, 1625 1st Street, NW,
7 license number ABRA-117346.

8 This is a Retailer Class CR for a
9 Substantial Change to hours of operation and
10 alcohol beverage sales, entertainment endorsement
11 with cover charge. The protest issues are
12 adverse impact on peace, order, and quiet.

13 My name is LaVerne Fletcher.
14 conducting the roll call hearing as the Board's
15 agent. Is anyone present on behalf of Mood
16 Swings Food Hall? Is anyone present on behalf of
17 ANC-5E?

18 MS. LEWIS: I am present. This is
19 Commissioner Karla Lewis, ANC-5E Chair, and the
20 establishment is also in my single-member
21 district.

22 MS. FLETCHER: Thank you, Ms. Lewis.
23 Would you spell your name for the record, please?
