3	MS. FLETCHER: Good morning, everyone.		
4	Thank you for participating in ABCA's public roll		
5	call hearings via the WebEx platform.		
6	My name is LaVerne Fletcher,		
7	conducting the roll call hearing as the Board's		
8	agent.		
9	There are two cases on the calendar		
10	today. The first case on the calendar is Nam's		
11	Market, case number 24-PRO-00018, Elharia, Inc.,		
12	1324 W Street, SE, license number ABRA-111233.		
13	This is a retailer Class B license		
14	renewal. The protest issues are adverse impact		
15	on peace, order, and quiet.		
16	My name is LaVerne Fletcher,		
17	conducting the roll call hearing as the Board's		
18	agent. Is anyone present on behalf of the		
19	Applicant? Is anyone present on behalf of the		
20	Applicant?		
21	Mr. Garedew, if I'm pronouncing your		
22	name correctly, are you unmuted now? Yes?		
23	MR. GAREDEW: Yes.		
24	MS. FLETCHER: Okay, just a moment,		
25	please. Would you please state your name and		

1	spell it for the record?
2	MR. GAREDEW: Sure. Henok Garedew,
3	H-E-N-O-K G-A-R-E-D-E-W.
4	MS. FLETCHER: Thank you very much.
5	Is anyone present on behalf of a Group of Five?
6	Is anyone present on behalf of a Group of Five?
7	Is anyone present on behalf of ANC-8A?
8	Ms. Lewis let's see, is Jamila
9	White here? Or Robin McKinney?
10	The time is approximately 10:05. We
11	allow at least ten minutes for parties to appear.
12	I'm going to recall this case in
13	(Whereupon, the above-entitled matter
14	went off the record at 10:06 a.m. and
15	resumed at 10:08 a.m.)
16	MS. FLETCHER: I'm recalling the case
17	of Nam's Market. Is anyone present on behalf of
18	the Group of Five or More?
19	The Five or More is actually not
20	required to appear today. I called someone from
21	the group just in case they're present.
22	This group was actually grandfathered
23	in by the ABC Board because they were previously
24	granted standing during a roll call hearing on
25	December 18, 2023, and the Board grandfathered

1	them in for this hearing. They were
2	grandfathered in by Board Order dated
3	February 14, 2024, Board Order number 2024-074.
4	So, the Group of Five is granted standing as a
5	protestant. Is anyone present on behalf of
6	ANC-8A?
7	ANC-8A is dismissed because no one is
8	present from the ANC. Mr. Garedew, are you still
9	there?
10	MR. GAREDEW: Yes, Mr. Fletcher. I'm
11	here.
12	MS. FLETCHER: I'm sorry?
13	MR. GAREDEW: Yes, I'm still here.
14	MS. FLETCHER: Okay, thank you.
15	ANC-8A is dismissed because they're not here
16	today. A Board Order will be issued to dismiss
17	ANC-8A. You will receive a copy of the Board
18	Order. If the ANC seeks reinstatement of its
19	protest, you will have an opportunity to respond
20	to their request to be reinstated. You have any
21	question about that?
22	MR. GAREDEW: No. Will the email will
23	be sent?
24	It will be a Board Order. It will be sent by
25	email.

1	MR. GAREDEW: Thank you.		
2	MS. FLETCHER: But we do have one		
3	group granted standing in this matter. That is		
4	a Group of Five or More. And you heard me		
5	explain that they're not here, but they've		
6	already been grandfathered in.		
7	MR. GAREDEW: Yes.		
8	MS. FLETCHER: Because they were		
9	grandfathered in during the roll call hearing on		
10	December 18, 2023.		
11	MR. GAREDEW: Yes, ma'am. I heard		
12	that.		
13	MS. FLETCHER: I'm going to give you		
14	a couple of date, Mr. Garedew, for upcoming		
15	proceedings. And I'll provide those dates to		
16	the designated representative of a Group of		
17	Five, is Patrick O'Keefe. His name is spelled		
18	P-A-T-R-I-C-K, last name O'Keefe, spelled		
19	O-'-K-E-E-F-E.		
20	The dates for a couple of upcoming		
21	proceedings are a status hearing on May 8, 2024,		
22	at 10:30 a.m.		
23	MR. GAREDEW: May 8th. Okay.		
24	MS. FLETCHER: The protest hearing		
25	is scheduled for June 8		

1	MR. GAREDEW: June 8th.
2	MS. FLETCHER: 2024, at 1:30 p.m.
3	We need to set a date for mediation also. But
4	I'm going to send you and Mr. O'Keefe the dates
5	for Mediation in an email. I'm going to provide
6	you with several dates from which you can
7	choose; the one that's most convenient for you
8	both.
9	MR. GAREDEW: Thank you.
10	MS. FLETCHER: You're very welcome.
11	Do you have any questions at all?
12	MR. GAREDEW: No, ma'am. Thank you
13	very much.
14	MS. FLETCHER: Okay, you're very
15	welcome. Thank you for coming. The roll call
16	hearing in the matter of Nam's Market is
17	concluded.
