1	MS. FLETCHER: Thank you.
2	Anybody else?
3	MR. DAVIS: John Davis, J-O-H-N

5	MS. FLETCHER: Mr. Davis.
6	Anyone else?
7	MS. LEFERT: Ann Lefert, A-N-N L-E-F as

6	MS. FLETCHER: How about 1:30?
7	MS. MAHMOUD: That's great for us as
8	well.
9	MS. FLETCHER: Well, would 1:30 work for
10	you, Ms. Goldstone?
11	MS. GOLDSTONE: Yes. And assuming I
12	can be there to represent, that works for me. But
13	I would just ask if neighbors who would like to be
14	there, too, if that time works for them if possible.
15	MS. FLETCHER: So I'm going to send the
16	Webex invitation to you, Ms. Goldstone. If there
17	are any other members of your group that would like
18	to attend or that you would like to attend, you can
19	just forward yours to them.
20	MS. GOLDSTONE: Okay. Thank you.
