3	CHAIRPERSON ANDERSON: Good morning,
4	everyone. As chairperson of the Alcoholic
5	Beverage Control Board for the District of
6	Columbia, in accordance with DC Code Section 2576
7	of the Open Meetings Act, I am welcoming you to
8	the regular scheduled meeting of the Alcoholic
9	Beverage Control Board.
10	This meeting is being conducted
11	pursuant to guidance made available by the
12	District of Columbia's Office of Open Government
13	regarding electronic meetings held by public
14	bodies during the public health emergency.
15	Pursuant to this guidance, notice of
16	today's meeting was provided 48 hours in advance
17	of the meeting on ABRA's website and on the
18	District's central meeting calendar. The notice
19	included a time, date, agenda, and call in or

2	Chairman of the Board. I would like to introduce
3	the other members of the ABC Board who are also

8	MEMBER SHORT: Mr. James Short
9	present.
10	CHAIRPERSON ANDERSON: Ms. Rafi
11	Crockett?
12	MEMBER CROCKETT: Rafi Crockett
13	present.
14	CHAIRPERSON ANDERSON: Ms. Jeni
15	Hansen?
16	MEMBER HANSEN: Jeni Hansen present.
17	CHAIRPERSON ANDERSON: Mr. Edward
18	Grandis?
19	MEMBER GRANDIS: Edward Grandis
20	present.
21	CHAIRPERSON ANDERSON: The Board has
22	five members in attendance for the conduct of
23	business today, and that constitutes a quorum.
24	Before we get underway with today's hearing
25	calendar, I need to make a few instructions very

clear so that the conduct of these hearings is 1 2 understood by everyone. 3 There are two cases on this morning's 4 calendar. Once your case is called, I will take 5 a moment for our IT specialist to elevate the rights for each party to enable their camera and 6 7 Then and only then will you have the microphone. 8 ability to enable your microphone. 9 Should you have any questions or 10 require technical assistance during the hearing, 11 please submit them using the question and answer 12 feature or email simone.andrews2@dc.gov. Our first order of business today is a 13 14 protest hearing and status, Case Number 15 21-PRO-00014, Lee's Liquor, License Number 16 095751. 17 Ms. Andrews, can you please elevate 18 the rights of the participants in this case, 19 please? 20 MS. ANDREWS: Sure, stand by. Mr. 21 Lee's has been elevated. Ms. Brown, your rights 22 have been elevated. That's all, Mr. Chair. 23 CHAIRPERSON ANDERSON: All right. Is 24 Mr. Thompson, is Mr. Thompson on the line? Is he 25

MS. ANDREWS: No, sir.
CHAIRPERSON ANDERSON: All right.
Good morning to everyone. What I'm going to ask
everyone to do, if you're not speaking, please
mute your microphone so that there won't be
feedback. So only open your microphone, unmute
your microphone if you are speaking, please.
All right, could I have everyone
identify themselves for the record starting with
the Applicant.
MR. LEE: Good morning, Board members,
my name is Kevin Lee, K-E-V-I-N L-E-E. I am
attorney for the Lee's Liquor in the matter of
protest of Lee's Liquor.
CHAIRPERSON ANDERSON: Mr. Lee, is the
licensee going to be here today? Are you
expecting him to participate?
MR. LEE: I am attorney on behalf of
the licensee. He is not here.
CHAIRPERSON ANDERSON: Thank you.
MR. LEE: Right.
CHAIRPERSON ANDERSON: Ms. Brown?
MS. BROWN: Tiffany Brown, ANC
Commissioner 7B02, Chair of ANC 7B, Protestant.
CHAIRPERSON ANDERSON: Good morning.

1	Oh, by the way, I just want to alert the public
2	that I do, I am aware, I'm sorry, I do know
3	Tiffany Brown, the ANC Commissioner for 7B. I
4	was an ANC commissioner through 2018, I believe.
5	And I served on the ANC as a member with Ms.
6	Brown.
7	However, I do not believe that my
8	knowledge of her and my knowledge of this ANC,
9	and also this establishment is within the
10	confines of ANC 7B where I live, however, I do
11	not believe that my knowledge of this
12	establishment or my knowledge of Ms. Brown would
13	have any weight in swinging me one way or the
14	other in making a decision. All right, thank
15	you.
16	It was my understanding -
17	(Simultaneous speaking.)
18	CHAIRPERSON ANDERSON: Yes, Mr. Short,
19	yes, sir?
20	MEMBER SHORT: I too would like to
21	state that I live in or I reside in ANC 7B. And
22	I do know ANC Commissioner. That would have no
23	bearing on my decision making in this process
24	today either. Thank you.
25	CHAIRPERSON ANDERSON: All right.
	-

Thank you, Mr. Short. 1 2 All right. It was my understanding 3 that the transfer was being protested by ANC 8A. 4 And conditional standing was granted to ANC 8A at 5 the roll call hearing. I do not see our commissioner from ANC 8A here today. Does anyone 6 7 know what's going on? Because I need to make a determination? 8 9 MS. BROWN: The commissioner, Brian 10 Thompson, he is out of town at this time for his 11 job. 12 CHAIRPERSON ANDERSON: Are you, Ms. 13 Brown, are you here representing the ANC, ANC 8A 14 or are you just representing ANC 7B? 15 MS. BROWN: Just 7B. But you asked if anyone knew. He mentioned, he emailed for our 16 17 mediation hearing that he would not be able to appear for mediation because of the work 18 19 obligation. 20 CHAIRPERSON ANDERSON: I'm sorry, what 21 do you mean he emailed mediation. 22 MS. BROWN: We had a mediation, we met 23 yesterday. And he indicated in that process by 24 email that he would not be at mediation. 25 CHAIRPERSON ANDERSON: That he would

1 not? Be at mediation. 2 MS. BROWN: He did 3 not say anything about the status hearing. 4 CHAIRPERSON ANDERSON: All right, 5 fine. Mr. Lee, is there a motion that you wish 6 to make? 7 First of all, I would just MR. LEE: 8 ask about that, Mr. Thompson from the ANC 8A 9 didn't notify anything to the status hearing to the Board. Does it affect his standing or 10 11 CHAIRPERSON ANDERSON: I'm sorry, what 12 did you say, Mr. Lee? He didn't notify his absence 13 MR. LEE: 14 to the status hearing to the Board. Does it 15 affect his standing for the protest? Because he 16 notify to only mediation session. 17 CHAIRPERSON ANDERSON: Mr. Lee? 18 MR. LEE: Yes, ha, ha, ha. 19 CHAIRPERSON ANDERSON: The question I 20 asked you, sir, is there a motion that you want 21 to raise? 22 MR. LEE: I want to. 23 CHAIRPERSON ANDERSON: What is the 24 motion to raise, sir? 25 Actually, this Mr. ANC 8A MR. LEE:

from the protest, standing -

2	CHAIRPERSON ANDERSON: Thank you. It
3	is clear to all parties that you are supposed to
4	appear at the status hearing. It was my
5	understanding that conditional standing was
6	provided to ANC 8A at the roll call hearing.
7	Initially, Counsel, it's my
8	understanding Counsel had objected to standing
9	being granted to ANC 8A. However, pursuant to
10	25601(a)4, an affected ANC is afforded standing
11	in a protest hearing. And so the determination,
12	at least at the roll call hearing, was that ANC
13	8A could have participated in this protest,
14	pursuant to 25601(a)4, as an affected ANC.
15	The ANC 8A has not informed the Board
16	that they would be unable to participate at this
17	hearing today. So therefore, I will make a
18	motion, a motion was made by the Applicant to
19	dismiss ANC 8A. And so therefore I will then
20	make a motion to the Board for the Board to
21	approve the motion and dismiss ANC 8A. Is there
22	a second?
23	MEMBER GRANDIS: Ed Grandis.
24	CHAIRPERSON ANDERSON: Mr. Grandis has
25	seconded the motion. I will now take a roll call

vote on the motion that's been properly seconded 1 2 by Mr. Grandis. 3 Mr. Short? Mr. Short, I agree. 4 MEMBER SHORT: 5 CHAIRPERSON ANDERSON: Ms. Crockett? MEMBER CROCKETT: Rafi Crockett, I 6 7 agree. 8 CHAIRPERSON ANDERSON: Ms. Hansen? 9 MEMBER HANSEN: Jeni Hansen, I agree. 10 CHAIRPERSON ANDERSON: Mr. Grandis? 11 Edward Grandis MEMBER GRANDIS: 12 agrees. 13 CHAIRPERSON ANDERSON: And Mr. 14 Anderson, I agree. The matter passed five, zero, 15 The Board has therefore dismissed ANC 8A zero. 16 from the protest. 17 By operation of law ANC 8A has ten 18 days, once the decision is issued, they have ten 19 days to give good notice or cause to the Board 20 why they were not available to attend this 21 hearing today. And if they were not available to 22 attend this hearing today, why did they not ask 23 someone to represent their interest today. 24 All right. Are there any other 25 preliminary issues that need to be brought to the

attention of the Board? 1 2 MR. LEE: I just really 3 CHAIRPERSON ANDERSON: Yes, Mr. --MR. LEE: Can I, yes. I just report 4 5 to the Board, yesterday we met at the mediation with the ANC 7B. And we decided to continue the 6 7 negotiation for the settlement agreement with ANC 8 7B. 9 CHAIRPERSON ANDERSON: All right, 10 thank you. Any preliminary issues, Ms. Brown? 11 MS. BROWN: I was going to also add it 12 appears that the Applicant has about three 13 different settlement agreements. And so we were 14 going to look to have a joint one with 8A and 7B, 15 and have the other one to be cancelled, 16 superseded, the new agreement be superseded. But 17 if 8A no longer has standing, then I'm not sure 18 how that goes, if they no longer have standing 19 about entering into a settlement agreement 20 CHAIRPERSON ANDERSON: Well, 8A no 21 longer has standing to participate in the protest 22 matter. Whatever is done as far as a settlement 23 agreement, that's between the parties. The Board 24 is not involved in those procedures. But I'm 25 just saying all that was done today was that they

did not have standing to participate in this protest proceeding.

3 However, as I've stated, once the Board order is issued, they will be given ten 4 5 days to respond, why is it that they should not be dismissed for their lack of appearance today. 6 7 But the Board takes no role in 8

whatever negotiation that occurs between the parties or whoever it is that the parties decide to include or not include in a settlement 11 So I just want that to be clear. agreement.

12 All right. This matter, if there are 13 no other preliminary matters, then this matter 14 will be scheduled for a protest hearing on June 15 10th at 1:30 p.m., so June 10th, at 1:30 p.m.

16 All right. Now that we have scheduled 17 this matter for a protest hearing, there are a 18 few things that I would like to instruct you 19 about. Because the Board's practices under the 20 COVID-19 restrictions have changed.

21 As you know, the Board's hearings are 22 conducted virtually. So it is more important 23 than ever that the protest hearings are focused 24 and address only those issues that have been 25 protested.

1	Following this hearing, you will be
2	receiving an email from AGC April Randall that
3	will include a copy of a Protest Information
4	Form, PIF, and a copy of an exhibit form, as well
5	as specific instructions for the hearing.
6	You are required to complete and
7	submit the PIF and exhibit form at least seven
8	days before the date of the hearing. If we do
9	not receive a copy of your forms seven days
10	before the hearing, your application or your
11	protest may be subject to dismissal.
12	These documents need to be submitted
13	to abra.legal.dc.gov and to the opposing parties.
14	Please note that these documents greatly assist
15	the Board in narrowing the protest issues,
16	facilitating the process, and keeping the parties
17	on point during the hearing.
18	Each side is limited to no more than
19	five witnesses, and you will only have 60 minutes
20	to present your case. This includes all direct
21	and cross examination. The Board does not intend
22	to hear testimony on matters that are not
23	relevant to these issues that are being
24	protested.
25	Are there any questions by anyone?

1	MR. LEE: No question, but -
2	MS. BROWN: No questions.
3	MR. LEE: Oh, sorry.
4	CHAIRPERSON ANDERSON: Go ahead.
5	MR. LEE: For the protest hearing
6	date, it's June 10th, 1:30?
7	CHAIRPERSON ANDERSON: June 10th at
8	1:30.
9	MR. LEE: Thank you.
10	CHAIRPERSON ANDERSON: Yes. All
11	right. We thank you for your - Yes, Mr. Short?
12	MEMBER SHORT: Yes, thank you. Just
13	for the record, I'd like to ask Commissioner
14	Tiffany Brown if she could enlighten us on the
15	boundaries between 7B and 8A? Because this is
16	being asked if they move within the same block.
17	And just for the record, I would like anyone who
18	reads the transcript to understand why we have
19	two ANCs involved in this proceeding.
20	CHAIRPERSON ANDERSON: Well, Mr.
21	Short, it's not, she doesn't have to give the
22	boundary because by operation of law, 25601(a)4
23	basically is stating an affected ANC. So
24	therefore, if any of the ANCs, the border, the
25	boundary, that boundary is the ANC.

1	So the establishment doesn't have to
2	be in 8A, because it's affected, because it's
3	right next to 8A. So that's why, in this
4	particular case, ANC 8A would have standing.
5	Because it's under the law, it's what's
6	considered an affected ANC.
7	MEMBER SHORT: Mr. Chair, just for the
8	record, what you said is completely correct, and
9	I do understand the statute. I would like
10	actually, if there is a street boundary that
11	separates the two, can that go on the record?
12	CHAIRPERSON ANDERSON: Ms. Brown, do
13	you know?
14	MS. BROWN: I believe it's Minnesota
15	Avenue which is right around the corner from
16	where the establishment is.
17	MEMBER SHORT: Thank you, that's what
18	I wanted on the record, sir. Thank you. Thank
19	you, Ms. Tiffany Brown.
20	MR. LEE: Mr. Chair?
21	CHAIRPERSON ANDERSON: Yes?
22	MR. LEE: I will add that at the local
23	hearing, I've just raised a standing issue about
24	the ANC 8A. But after that I found that there is
25	a previous, there was a previous boundary limit

with the ANC 8A, so two boundary limits before. 1 So I thought that is only the Board could discuss 2 3 about the standing issue about the ANC 8A. 4 That's why I didn't write a letter to the Board to make an issue about it. 5 CHAIRPERSON ANDERSON: Thank you, Mr. 6 7 Lee. 8 (Simultaneous speaking.) 9 MR. LEE: -- for your report. Yes. 10 CHAIRPERSON ANDERSON: Well, thank 11 you, Mr. Lee. And so that's why that's stated as 12 pursuant to 25601(a)4, 8A is an affected, as per 13 the statute, 8A is an affected ANC. And so 14 therefore, although the establishment might not 15 necessarily be within the boundaries of ANC 8A 16 because, as per the statute, it's an affected 17 And that's all over the city. ANC. If there is an establishment that's in 18 19 an affected ANC in the sense that, although the 20 establishment, it's not within, that's just if 21 the ANC, if they are an affected ANC as per the 22 statute, then they automatically have standing to 23 protest the renewal or any changes that are being 24 made to the license of an establishment. **All** 25 right, thank you.

1	All right. So we thank you greatly
2	for your cooperation. If you have any questions

6	Thank you very much for your
7	participation today. Good luck in your

12	prefer that there are settlement agreements,
13	because the community and the establishment could
14	amicably work out their differences, and the
15	Board would not have to make a decision for them.
16	So good luck in your continued negotiations. And
17	have a great day. Thank you.
18	MR. LEE: Thank you very much. Thanks
19	for your time.
20	CHAIRPERSON ANDERSON: All right,
21	goodbye.
