3 CHAIRPERSON ANDERSON: We now move to  
4 our Show Cause Hearing Status Calendar, and the  
5 first case on the Show Cause Hearing Status  
6 Calendar is Case Number 23-CMP-00082, Kezira  
7 Lounge, License Number 117490. Good morning Mr.  
8 Orellana, can you please elevate the rights of  
9 the Government and the licensee in this case?

10 MR. ORELLANA: Matthew Emmick, your  
11 access has been elevated. That appears to be all  
12 Chairman.

13 CHAIRPERSON ANDERSON: Thank you. Good  
14 morning, Mr. Emmick. Can you please spell and  
15 state your name for the record?

16 MR. EMMICK: Good morning to the  
17 members of the Board. This is Assistant Attorney  
18 General Matthew Emmick, M A-T-T-H-E-W, E-M-M-I-C-  
19 K, on behalf of the District.

20 CHAIRPERSON ANDERSON: Thank you. Good  
21 morning. I see that the licensee is not here,  
22 but at show cause hearing status the licensee is  
23 not required to be here. This matter is scheduled  
24 for a show cause hearing on June 5, 2024 at 10:30  
25 a.m. I just want to remind the Government that

1 if this matter actually goes to a show cause  
2 hearing seven days before the hearing the parties  
3 are required to exchange documents and witnesses.  
4 Failure by either side to exchange documents and  
5 witnesses seven days prior to hearing, unless  
6 good cause is shown, the Board is empowered to  
7 prevent that party from relying on documents that  
8 have not been disclosed. Any questions?

9 MR. EMMICK: No, Mr. Chairman. I would  
10 just note that it is my understanding from my  
11 colleague that the establishment is also on the  
12 cancellation docket, so it may be a moot point by  
13 the time we get to the show cause hearing, but I  
14 will be sure to relay that to my counterpart.

15 CHAIRPERSON ANDERSON: Thank you, sir.  
16 Yes, I will be later on this morning when I read  
17 the cancellation agenda the Board will be  
18 cancelling the license, but, again, this is a  
19 case that is still on our show cause hearing  
20 calendar for the morning, and I have not done the  
21 cancellation agenda yet. So, therefore, we have  
22 to move through the process. All right. Thank  
23 you.
