And what this means, Mr. Martin, is that if you're contesting this matter, you need to -- seven days before the hearing you need to exchange with the assistant attorney general who this case is assigned to -- you need to provide them with a copy of the documents and witnesses that you will rely upon. And you are also required to share a copy of the documents and witnesses that you're relying upon with the Board.

Failure by either side to provide documents -- to exchange documents and witnesses, the Board is empowered to prevent that side from relying on documents that have not been disclosed.
