3 CHAIRPERSON ANDERSON: All right. The
4 next case on our calendar is Case No. 23-CMP-
5 00006, Sticky Rice/Sing Sing Karaoke Palace,
6 License No. 72783.

7 Mr. Orellana, can you please elevate
8 the rights of the Licensee in this case?

9 MR. ORELLANA: Sure thing. Jason
10 Martin, your access has been elevated.

11 That is all, Chair.

12 CHAIRPERSON ANDERSON: Thank you.

13 MR. MARTIN: Yes, hi, this is --

14 CHAIRPERSON ANDERSON: Mr. Martin, do
15 you have a camera you -- yes. Okay. Fine.

16 MR. MARTIN: Yes, good morning.

17 CHAIRPERSON ANDERSON: Good morning.

18 Mr. Emmick, good morning again. Can
19 you please identify yourself for the record?

20 MR. EMMICK: Yes, good morning.

21 Assistant Attorney General Matthew Emmick, M-A-T-
22 T-H-E-W, E-M-M-I-C-K, on behalf of the District.

23 CHAIRPERSON ANDERSON: Good morning,
24 sir.

25 Mr. Martin, can you spell and state

1 your name for the record and identify your
2 relationship to this establishment?

3 MR. MARTIN: Jason Martin, J-A-S-O-N,
4 M-A-R-T-I-N. I'm the owner of Sticky Rice at Bee
5 Hive, LLC.

6 CHAIRPERSON ANDERSON: Good morning,
7 sir.

8 All right. Mr. Emmick, are there any
9 preliminary matters in this case?

10 MR. EMMICK: I can share with the
11 Board that we have been in settlement discussions
12 up to this point, but it's my understanding and
13 belief that we need to keep the show cause
14 hearing as presently scheduled on the calendar.

15 CHAIRPERSON ANDERSON: All right.
16 Fine. Any preliminary matter you want to bring
17 to the attention, Mr. Martin? Just preliminary.

18 MR. MARTIN: No.

19 CHAIRPERSON ANDERSON: Okay. All
20 right. Fine. All right. Thanks.

21 Then this matter is scheduled for a
22 show cause hearing on May 15th at 1:30 p.m. I
23 would like to remind the parties that if this
24 matter goes to an actual hearing seven days
25 before the hearing both parties are required to

1 exchange documents and witnesses.

2 And what this means, Mr. Martin, is
3 that if you're contesting this matter, you need
4 to -- seven days before the hearing you need to
5 exchange with the assistant attorney general who
6 this case is assigned to -- you need to provide
7 them with a copy of the documents and witnesses
8 that you will rely upon. And you are also
9 required to share a copy of the documents and
10 witnesses that you're relying upon with the
11 Board.

12 Failure by either side to provide
13 documents -- to exchange documents and witnesses,
14 the Board is empowered to prevent that side from
15 relying on documents that have not been
16 disclosed.

17 Any questions by anyone?

18 MR. MARTIN: No.

19 MEMBER SHORT: The date for the
20 hearing again, please?

21 CHAIRPERSON ANDERSON: The hearing is
22 scheduled for May 15th at 1:30 p.m.

23 MEMBER SHORT: Thank you.
