3 CHAIRPERSON ANDERSON: Good afternoon,
4 everyone, and welcome to the afternoon session of
5 the ABC Board. My name is Donovan Anderson, and I
6 am Chairman of the Board. Joining me this
7 afternoon are five other board members: Mr. James
8 Short, Mr. Bobby Cato, Ms. Rafi Crockett, Ms.
9 Jeni Hansen, Mr. Edward Grandis.
