3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 23-PRO-00033, Slice &
5 Pie/Lucy, License No. 118631

6 Mr. Orellana, can you please elevate
7 the rights of the Licensee and the Protestant in
8 this case.

9 MR. ORELLANA: Manalle Mahmoud, your

10 MS. MAHMOUD: No, Mr. Chair. We've
11 actually worked a settlement agreement and I
12 believe the ANC will be voting on it tomorrow.

13 MR. LAKATOS: Correct.

14 CHAIRPERSON ANDERSON: All right. If
15 this matter is settled, then we'll have a protest
16 hearing on June 28, 2023. As you stated, the
17 settlement agreement needs a vote. Once the
18 settlement agreement is provided to the Agency,
19 the Board will vote and more than likely approve
20 it and so we'll have a hearing on the 28th.
21 Okay?

22 I'm hoping that the ANC signs off on
23 the settlement agreement. I'm also glad that the
24 parties were able to come to a mutual agreement
25 on what's best for the licensee and what's best

1 for the residence. All right. Thank you both.
2 Have a great day.

3 MR. LAKATOS: Thank you.

4 MS. MAHMOUD: You, too. Thank you.
