3 CHAIRPERSON ANDERSON: Good afternoon.

4 We're back on the record. Good afternoon,
5 everyone, and welcome to the afternoon session of
6 the A -- good afternoon, everyone, and welcome to
7 the A -- the afternoon session of the ABC Board.

8 My name is Donovan Anderson, I'm
9 Chairman of the Board, and joining us this
10 afternoon are five other Board Members, Mr. James
11 Short, Mr. Bobby Cato, Ms. Rafi Crockett, Ms. Jen
12 -- Jenni Hansen, Mr. Edward Grandis. The Board
13 has six members in attendance of the conduct
14 today and that constitutes a quorum.

15 Before we get underway, Ms. -- this
16 afternoon's calendar, I need to make a few
17 instructions very clear, so that the content of
18 this hearing is understood by everyone.

19 There are currently two cases
20 scheduled for our calendar this afternoon. Once
