3 CHAIRPERSON ANDERSON: The next case in
4 our calendar is Case Number 25-CMP-00047. Chop
5 Shop, Nice N Easy, License Number 124675. Mr.
6 Orellana, can you please elevate the government
7 and the licensee in this case, please?

8 MR. ORELLANA: Sure thing. Shani Brown,
9 access elevated. And I'm going to ask in the chat
10 if the licensee is there.

11 CHAIRPERSON ANDERSON: Thanks.

12 MR. ORELLANA: Chairman, just to clarify,
13 the KVIC hearing is cancelled?

14 CHAIRPERSON ANDERSON: Yeah, I don't know
15 why. I see that someone stated that they were

23 the protest was dismissed. I don't know which
24 one. So that person, yeah, that person should
25 contact legal to get clarification.

3 CHAIRPERSON ANDERSON: Well, that's fine
4 because this is a short cause hearing status and
5 there's no requirement. So good morning, Ms.
6 Brown. Can you please identify yourself for the
7 record?

8 MS. BROWN: Good morning. This is
9 Assistant Attorney General Shani Brown. That's
10 spelled S-H-A-N-I, B-R-O-W-N, here on behalf of
11 the District.

12 CHAIRPERSON ANDERSON: Good morning. All
13 right. The licensee is not here. However, at
14 short cause hearing status, there's no requirement
15 for the licensee to be here. If this matter is
16 not settled, it is then scheduled for a short
17 cause hearing on June 10th at 10:30 a.m. Just
18 want to remind the parties that seven days before
19 the date of the hearing, the parties are required
20 to disclose documents and witnesses that they will
21 rely upon at the hearing. Failure by either side
22 to disclose documents or witnesses timely, the
23 Board is empowered to prevent that side from
24 relying on those documents. Any questions, ma'am?

25 MS. BROWN: No.
