3 CHAIRPERSON ANDERSON: We have now
4 completed -- concluded our morning calendar, and
5 so let's now do our legal agenda for the morning.

6 The first matter on our legal agenda
7 is a review of an Offer in Compromise in lieu of
8 a hearing dated May 2, 2023, for Case Number 23-
9 CMP-00004, Justin's House of Bourbon, License
10 Number 116888.

11 The Offer in Compromise reads as
12 follows. Charge 1, misused the establishment's
13 approval off-premises storage facility.
14 Statutory authority 23 DCMR Section 209. This
15 charge has been dismissed.

16 Charge 2, illegally transport
17 alcoholic beverage within the District.
18 Statutory authority 23 DCMR Section 1303.1. That
19 charge has also been dismissed.

20 Charge 3, fails to keep and maintain
21 books and records on premises. Statutory
22 authority 23 DCMR Section 1208. There is a fine
23 of \$1,500, payable within 30 days or the license
24 shall be suspended indefinitely until the fine is
25 paid.

1 Charge 4, interfered with an ABRA --
2 ABCA investigation by failure to -- failing to
3 produce documents within 48 hours. Statutory
4 authority DC Code Section 25-823(a)(5)(E). For
5 this charge, there is a fine of \$1,500, payable
6 with 30 days or the license shall be suspended
7 indefinitely until the fine has been paid.

8 I, therefore, make a motion that the
9 Offer in Compromise be accepted. Is there a
10 second?

11 license shall be suspended indefinitely until the
12 fine is paid.

13 Charge 2, failed to follow settlement
14 agreement. Statutory authority DC Code Section
15 25-823(b)(6). That charge has been dismissed.

23 MEMBER CATO: Bobby Cato. I agree.

24 CHAIRPERSON ANDERSON: Ms. Hansen.

25 MEMBER HANSEN: Jeni Hansen. I agree.

1 CHAIRPERSON ANDERSON: Mr. Grandis.

2 MEMBER GRANDIS: Edward Grandis. I
3 agree.

4 CHAIRPERSON ANDERSON: And Mr.
5 Anderson. I agree. The matter passes five-zero-
6 zero.

7 (Pause.)
