8                   I therefore make a motion that the ABC  
9                   Board vacate the orders, the cease and desist  
10                  orders for the establishments that were just read

3 The next establishment is Best Deals  
4 Wine, License Number 104641. The licensee did  
5 not renew its license.

6 Best 1 Liquors, License Number 109545.  
7 The licensee did not renew its license.

8 To Be Determined, formerly VD 3, LLC.  
9 License Number 108288. The licensee did not  
10 renew.

11 And so therefore, those are the  
12 establishments. I make a motion that the ABC
