3 CHAIRPERSON ANDERSON: All right.

4 We're back on the record. All right, we're going  
5 to do our legal agenda.

6 The first matter on our legal agenda  
7 is a review of an Offer in Compromise and both a  
8 hearing dated May 23, 2022 for Case Number 22-CC-  
9 00002, Church/Georgetown Wing, License Number  
10 119851.

11 The Offer in Compromise is as follows:  
12 Charge Number One, sale of an alcoholic beverage  
13 to minor, statutory authority D.C. Code Section  
14 25781.

15 There is a fine of \$3,000 payable  
16 within 120 days of the Board's acceptance of the  
17 OIC. If payment is not made within 120 days, the  
18 license will be suspended until payment is made.

19 Additional term, the license shall be  
20 suspended for five days. All five days will be  
21 stayed for one year.

22 And all employees who serve alcoholic  
23 beverages in the licenses establishment completes  
24 an alcohol training program within three months  
25 from the OIC's date.

1 Charge Number Two, failure to take  
2 reasonable steps necessary to ascertain legal  
3 drinking age, statutory authority, D.C. Code  
4 Section 25783. The fine, a warning will be  
5 issued in this case.

6 I therefore make a motion that the ABC  
7 Board accept the Offer in Compromise. Is there a
