9 reimbursement for RDO services to the
10 pre-COVID-19 pandemic hours of 11:30 p.m. to 5:00
11 a.m., Sunday through Saturday.

12 Number two, to restoring the hours of
13 eligibility for obtaining reimbursement for RDO
14 services for temporary license holder or those
15 approved for a one-day suspension to each license
16 to the pre-COVID-19 pandemic hours of 24 hours a
17 day.

18 And Number three is to add in the DC
19 Main Street's program to the list of entities
20 eligible for participation in the RDO subsidy
21 program.

22 I therefore make a motion that the ABC

6 new ABC license application.

8 Beverage, License Number 60518. They are a
9 Wholesaler A. This is a gift and loan
10 application for a soda stream machine.

11 The next request is a request made by
12 DCity Smokehouse, License Number 118390. They
13 are a caterer. This is a new ABC license
14 application.

15 The next request is a request made by
16 Dlena, License Number 117926, they are a Retailer
17 C restaurant. It's a new ABC license
18 application.

19 And the last request is a request made
20 by Reboot Beverages, License Number 118291.
21 They are a Wholesaler A. And this is for a new
22 ABC license application.
