4	calendar is Dix Market, Case Number 24-PRO-00043,
5	Ezra S, Inc., 6221 Dix Street, Northeast, License
6	Number ABRA 116408.
7	This is a Retailer Class A liquor
8	store license renewal. The protest issues are
9	adverse impact on peace, order, and quiet,
10	residential parking, and vehicular and pedestrian
11	safety.
12	My name is LaVerne Fletcher,
13	conducting the roll call hearing as the Board's
14	Agent. Is anyone present on behalf of Dix
15	Market?
16	MR. GGIORGIS: Yes. My name is Dawit,
17	last name Ggiorgis. D-A-W-I-T, last name G-G-I-
18	O-R-G-I-S.
19	MS. SHEFERAW: And, this is Faseka, F-
20	A-S-E-K-A
21	MS. FLETCHER: Excuse me. Excuse me
22	one second. Can you state your name again?
23	MR. GGIORGIS: Dawit, D-A
24	MS. FLETCHER: Not you. Not you, the
25	other person.

1	MS. SHEFERAW: Faseka, F-A-S-E-K-A.
2	MS. FLETCHER: Okay. Can you slow
3	down for me?
4	MS. SHEFERAW: F- as in Frank,
5	MS. FLETCHER: Uh-huh.
6	MS. SHEFERAW: A-S
7	MS. FLETCHER: Uh-huh.
8	MS. SHEFERAW: E-K-A,
9	MS. FLETCHER: Uh-huh.
10	MS. SHEFERAW: Last name S- as in Sam,
11	MS. FLETCHER: The last name was?
12	MS. SHEFERAW: S- as in Sam,
13	MS. FLETCHER: Uh-huh.
14	MS. SHEFERAW: H-E-F- as in Frank, E-
15	R-A-W.
16	MS. FLETCHER: E-R-A-W. Thank you,
17	very much. Okay. Is there anyone present on
18	behalf of ANC 7C?
19	MR. HOLMES: Chair Antawan Holmes.
20	MS. FLETCHER: Mr. Holmes, would you
21	spell your name for the record, please?
22	MR. HOLMES: A-N-T-A-W-A-N H-O-L-M-E-

24	MS. FLETCHER: Thank you. Anyone else
25	present from ANC 7C, Mr. Holmes?

1 MR. HOLMES: Not on the call. Not at 2 this time. 3 MS. FLETCHER: Okay. Thank you. Mr. 4 Holmes, I'm going to ask you to confirm the 5 number of Commissioners that have to be present to establish a quorum. 6 7 MR. HOLMES: Five of nine. 8 MS. FLETCHER: Thank you. So, I'm 9 noting for the record that a quorum was present 10 during your vote to protest the application. 11 And, Mr. Holmes, if you would just 12 include the number that makes up a quorum going 13 forward. ANC 7C does have standing as a 14 protestant. 15 We need to set a date for mediation, 16 a status hearing, and a protest hearing. 17 give you the date for the status and protest 18 hearing first. The status hearing is scheduled for 19 20 June 26 at 10:30 a.m. The protest hearing is set 21 for July 27 at 1:30 p.m. 2.2 We need to set a date for mediation. 23 I'll give you the next available day. The next 2.4 available date for mediation is Friday, June 7, 25 anytime between 10:30 and 1:30.

3	MR. HOLMES: That doesn't work for me.
4	MS. FLETCHER: Okay. Who said who
5	said that?
6	MR. HOLMES: This is Antawan Holmes,
7	Commissioner Holmes.
8	MS. FLETCHER: Okay. Mr. Holmes
9	(Simultaneous speaking.)
10	MR. HOLMES: That date
11	MS. FLETCHER: I'll move to the
12	following week
13	MR. HOLMES: Fridays don't work.
14	MS. FLETCHER: I'm sorry, what did you
15	say, Mr. Holmes?
16	MR. HOLMES: I said Fridays do not

2	MS. FLETCHER: Okay. So, we'll move
3	to the next day. So, let me ask you something.
4	MS. SHEFERAW: So, Mr. Holmes, will
5	Fridays work for you?
6	MS. FLETCHER: Faseka Faseka, let
7	me ask you something.
8	MS. SHEFERAW: Okay.
9	MS. FLETCHER: What would be a good
10	time for you, if you're having surgery on that
11	day, we need to move the date.
12	MS. SHEFERAW: Fridays would be per
13	any Fridays are perfect.
