4 in our calendar is Case Number 20-CIT-00577, the
5 Dirty Goose. License Number 101299.

6 Ms. Andrews, can you please elevate
7 the rights of the Licensee in this case, please?
8 The Dirty Goose.

9 MS. ANDREWS: Sure. Standby.

10 CHAIRPERSON ANDERSON: Thank you.

11 MS. ANDREWS: Mr. Bianco, your rights
12 have been elevated.

13 MR. BIANCO: Thank you.

14 MS. ANDREWS: That's all, Mr. Chair.

15 CHAIRPERSON ANDERSON: Thank you.
16 Good morning, Mr. Bianco. You're one of the
17 first attorneys that keep us calling. You made
18 sure you said this is not my case, I want nothing
19 to do with that case. I appreciate that. Thank
20 you, sir. All right.

21 All right, let me have the parties
22 introduce themselves by stating and spelling
23 their names for the record. I'll start with the
24 Government, please.

25 MS. JORDAN: Janika Jordan on behalf

1 of the Government. J-A-N-I-K-A, J-O-R-D-A-N.

2 CHAIRPERSON ANDERSON: All right, your
3 extension, Ms. Jordan. Mr. Bianco?

24 the show cause hearing. I thought I had it, but
25 I do not have the date, so I will make sure that

1 the Agency provides you, shortly, with a date of
2 the show cause hearing.

3 I just want to remind the parties that
4 seven days before the date of the hearing the
5 Board requires that you exchange documents and
6 witnesses to be provided to the other side. You
7 also provide it to, I'm sorry, they also provide
8 it to the Agency.

9 The show cause hearing will be
10 scheduled for July 28th at 10:30 hearing. So,
11 July 28th at 10:30 a.m. is the date of the show
12 cause hearing, all right?

13 MS. JORDAN: Thank you.

14 CHAIRPERSON ANDERSON: All right,
15 thank you very much.

16 MR. BIANCO: Thank you.

17 CHAIRPERSON ANDERSON: Have a great
18 day then. All right.

19 MR. BIANCO: Have a nice day.

20 CHAIRPERSON ANDERSON: All right.
