3 MS. FLETCHER: The next case on the  
4 calendar is American Cruise Lines, American  
5 Glory. This is Case No. 24-PRO-00050, American  
6 Cruise Lines, Inc. 970 Wharf Street SW, License  
7 No. ABRA 127817--2. This is a Retailer CX Marine  
8 Vessel for a new application.

9 The protest issues are adverse impact  
10 on peace, order, and quiet.

11 My name is Laverne Fletcher,  
12 conducting the roll call hearing as the Board's  
13 Agent.

14 Is anyone present on behalf of the  
15 Applicant?

16 MS. GORE: Yes, good morning, Ms.

25 MS. FLETCHER: Ms. Gore, can you state

2 MS. GORE: A-B-I-G-A-I-L, it's Abigail.

3 MS. FLETCHER: Oh, Abigail. Okay,  
4 thank you very much.

5 Is anyone present on behalf of ANC 6D?

6 MR. LINK: Good morning, Ms. Fletcher.  
7 This is Commissioner Bob Link, 6D01, B-O-B L-I-  
8 N-K.

9 MS. FLETCHER: Thank you, Mr. Link.

10 ANC 6D does have standing as  
11 Protestant. We need to set a date for mediation,  
12 a status hearing and protest hearing. I will  
13 give you the dates for the status and protest  
14 hearings first.

15 The status hearing is set for June  
16 26th, June 26, 2024, at 10:30 a.m., for the status  
17 hearing. The protest hearing is set for July 31,  
18 2024, at 1:30. That's for the protest hearing,  
19 July 31.

20 I will give you the next available  
21 date for mediation. The next available day is  
22 Thursday, June 20, any time between 10:30 and  
23 1:30. That's the next available day.

24 MS. GORE: We can do any time, whatever  
25 works for Mr. Link.

1 MS. FLETCHER: You can do the 20th, Ms.  
2 Gore?

3 MS. GORE: Yes.

4 MS. FLETCHER: Mr. Link, what about  
5 you?

6 MR. LINK: My response is the same.

7 MS. FLETCHER: How about 10:30?

8 MR. LINK: Yes, ma'am.

9 MS. FLETCHER: 10:30 June 20 for  
10 mediation. I will send you the Webex invitation  
11 to attend the mediation. Any questions at all?

12 Okay. Well, thank you for coming.  
13 The roll call hearing in this matter is  
14 concluded, and Mr. Link, the next case is yours  
15 as well.
