10 CHAIRPERSON ANDERSON: Mr. Short has
11 seconded the motion. We will now have a Roll
12 Call Vote on the motion.

13 Mr. Short.

14 MEMBER SHORT: Mr. Short, I agree.

15 CHAIRPERSON ANDERSON: Mr. Cato.

16 MR. CATO: Bobby Cato, I agree.

8 applicant from Nazca Restaurant which is also
9 Mochica Restaurant, License Number 118223. This
10 is a Retailer C Restaurant. This is a transfer
11 without sale application.

12 The next request, a request made by
13 Residence Inn by Marriott, Washington Capitol
14 Hill Navy Yard, License Number 118427. This is a
15 Retailer C Tavern. It is a transfer with sale
16 application.

17 The third request, a request made by
18 Jean Carlo Navedo. This is for a personal
19 importation permit application. The license
20 number is 21-IMP- 00013 in the sense that they
21 are requesting a personal importation permit.

22 I then make a motion that the ABC
23 Board grant the request made by the Applicant on
24 this docket that was just read in the record.

25 Is there a second?

1 MEMBER CROCKETT: Ms. Crockett,
2 seconds.

3 CHAIRPERSON ANDERSON: Ms. Crockett has
4 seconded the motion.

5 We'll now have a Roll Call Vote on the
6 motion that was properly seconded by Ms.
7 Crockett.
