The Alcoholic Beverage Control Board met via WebEx videoconference, LaVerne Fletcher, Board's Agent, presiding.

1 P-R-O-C-E-E-D-I-N-G-S 2 10:21 a.m. 3 MS. FLETCHER: The next case on the 4 calendar is Uncaged Mimosas. This is Case No. 5 22-PRO-00040, Uncaged Mimosas, LLC, 300 Florida Ave., NW, License No. ABRA-120889. This is a 6 7 Retailer Class CT new application. 8 The protest issues are adverse impact 9 on peace, order, and quiet, and residential 10 parking, and vehicular traffic. My name is 11 Laverne Fletcher conducting the roll call hearing 12 as the Board's agent. 13 Is anyone present on behalf of Uncaged 14 Mimosas? 15 Sidon Yohannes, MS. YOHANNES: Yes. 16 present on behalf of the applicant. That's S-I-17 D-O-N Y-O-H-A-N-N-E-S. 18 MS. FLETCHER: Thank you. ANC-5E is 19 a protestant and I have been informed that the 20 representative for ANC-5E actually came to the 21 office --22 MS. LEWIS: Yes, I'm in a building. 23 Can you hear me? 24 MS. FLETCHER: Ms. Lewis, thank you.

I was just about to grant you standing because I

	know you were here but you're present now. Good
2	morning.
3	MS. LEWIS: Thank you. Yes, I'm
4	sorry. I was out of the country until yesterday
5	and we are unable to get emails from out of the
6	country unless you go through this whole process.
7	I came to the office this morning and found out
8	that it was virtual, but I'm here.
9	MS. FLETCHER: Well, yes you are. I
10	saw you a minute ago
11	MS. LEWIS: Okay. There is something
12	going
13	MS. FLETCHER: Thank you. What did
14	you say, Ms. Lewis?
15	MS. LEWIS: No, I was having
16	difficulty with the audio.
17	MS. FLETCHER: Okay. Can you hear me
18	okay now?
19	MS. LEWIS: Yes. I don't know what
20	happened to the video. I had the video but now
21	it's only in audio mode.
22	MS. FLETCHER: That's okay. I can
23	hear you, I can see your name so that's
24	sufficient. Thank you.
25	MS. LEWIS: Okay. Thank you.

1	MS. FLETCHER: We also have we also
2	have Mr. Kupfer.
3	Mr. Kupfer, are you present
4	representing the Hart Wardman, LLC?
5	MR. KUPFER: I am. It's Jeff, J-E-F-
6	F, Kupfer, K-U-P-F-E-R. Thank you.
7	MS. FLETCHER: Mr. Kupfer, you
8	represent the Hart Wardman, LLC. I'm going to
9	spell that for the record. Hart is spelled H-A-R
10	T. Wardman is spelled W-A-R-D-M-A-N, LLC. Hart
11	Wardman, LLC is the owner of 302 Florida Avenue
12	and 304 Florida Avenue, NW?
13	MR. KUPFER: That is correct. I'm one
14	of the managing members of that entity.
15	MS. FLETCHER: Thank you. You filed
16	the protest as an abutting property owner?
17	MR. KUPFER: Correct.
18	MS. FLETCHER: I checked the DC
19	Geographic Information System and it does appear
20	that 302 Florida Avenue abuts 300 Florida Avenue,
21	NW, the address of the licensee so standing is
22	granted to the Hart Wardman, LLC as an abutting
23	property owner for that reason.
24	I also checked the location of 304
25	Florida Avenue, NW, and it appears that 304

Florida Avenue, NW, actually abuts 302. Is that 1 2 correct, Mr. Kupfer? 3 MR. KUPFER: That is correct. 4 MS. FLETCHER: Okay. So 304 abuts 302 5 but not 300 Florida and so those two buildings are not abutting. Because 302 abuts 300 Florida, 6 7 you're granted standing as an abutting property 8 owner, but 304 does not appear to abut. 9 have any comments you would like to make about that? 10 11 MR. KUPFER: Yeah. I mean, that's 12 correct in terms of the geography or whatever. 13 302 and 304 are neighboring brownstones. 14 are in the process of being redeveloped into one 15 condo development of which there will be one common entrance and condo units will be in both 16 17 of those previously-existing properties. It will 18 be one building. 19 MS. FLETCHER: Yes. Okay. Well, the 20 Hart Wardman, LLC has standing as an abutting 21 property owner because 302 abuts 300. 22 Thank you. MR. KUPFER: 23 MS. FLETCHER: You have standing as an 24 abutting property owner. You're welcome. Т 25 also, just for the record, confirmed that Hart

Wardman is the owner of 302 and 304 Florida 1 2 Avenue, NW. 3 I confirmed that through the DC Office 4 of Planning website called PropertyQuest. 5 PropertyQuest is spelled Property and the letters Q-U-E-S-T. We have ANC-5E as a protestant and 6 7 Hart Wardman, LLC as a protestant as an abutting 8 property owner. 9 I'll give you the dates for a status 10 hearing and a protest hearing and then we'll set 11 a date for mediation. The status hearing is 12 scheduled for July 13, 2022, at 10:30 a.m. July 13 13 at 10:30. The protest hearing is set for 14 August 10, 2022, at 1:30. I'll give you the 15 next available date for mediation. I have an issue with --16 MS. LEWIS: 17 Who is speaking? MS. FLETCHER: MS. LEWIS: This is Karla Lewis on 18 19 behalf of ANC-5E. 20 MS. FLETCHER: Yes. 21 MS. LEWIS: I have an issue with the 22 protest hearing date. 23 What you can do, Ms. MS. FLETCHER: 24 Lewis, beyond today you may petition the ABC 25 Board through Martha Jenkins, our general counsel

1	to reschedule that with a copy of that request to
2	Sidon Yohannes.
3	MS. LEWIS: Um-hum.
4	MS. FLETCHER: Do you have her contact
5	information?
6	MS. LEWIS: I have Sidon's email
7	address.
8	MS. FLETCHER: Okay.
9	MS. LEWIS: I have Martha Jenkins'
10	information as well.
11	MS. FLETCHER: And if you would copy
12	also Mr. Kupfer.
13	MS. LEWIS: Yes. And I have his
14	information as well.
15	MS. FLETCHER: Okay. That's what you
16	can do, Ms. Lewis, make that request and copy the
17	individuals I just named, send it to Martha
18	Jenkins and she'll review it and get back to you.
19	MS. LEWIS: Okay. I appreciate that.
20	MS. YOHANNES: I'll just say,
21	Commissioner, if you want to contact me, I'm
22	happy to talk to you about that, another date.
23	MS. LEWIS: Okay. I mean, it may not
24	even be necessary. We are already talking, Ms.
25	Fletcher, and we're hoping that we will come to

1 some type of a settlement agreement. 2 MS. FLETCHER: Okay. That's great. 3 That would be the ideal situation. I've made a 4 note that you are going to petition the Board to 5 change the protest hearing date just in case it doesn't work out. 6 7 MS. LEWIS: Yes. 8 MS. FLETCHER: Thank you very much. 9 Let me give you the next available date for mediation. Let's see. What about --10 11 Ms. Yohannes, in a previous case did 12 you say you're not available on June 29th? 13 MS. YOHANNES: I may have. Hold on. 14 I'm sorry. Let me check my calendar. Right, due 15 to a potential protest hearing. 16 MS. FLETCHER: Excuse me one second. 17 One of my co-workers is calling. This may be 18 something I need to know. 19 Sorry. So, Ms. Yohannes, the 29th is 20 a day that you're not available. Right? 21 As of now, yes. MS. YOHANNES: 22 MS. FLETCHER: What about -- what did 23 you say about June 28th, Ms. Yohannes? Were you 24 available June 28th, or did I offer that date? 25 MS. YOHANNES: Yes, I'm available on

1	the 28th.
2	MS. FLETCHER: Okay.
3	Ms. Lewis, are you available on the
4	28th?
5	MS. LEWIS: Yes, it looks like I'm
6	available on the 28th.
7	MS. FLETCHER: Mr. Kupfer, what about
8	you?
9	MR. KUPFER: Looks like I'm available,
10	though maybe not in the morning potentially. I'm
11	not sure what time you're thinking about.
12	MS. FLETCHER: Well, we can do it at
13	1:00 in the afternoon if that would help, or
14	1:30.
15	MR. KUPFER: That would be preferable
16	from my standpoint.
17	MS. FLETCHER: Do you have a
18	preference for 1:00 or 1:30?
19	MR. KUPFER: 1:30 is probably safer if
20	that works for others.
21	MS. LEWIS: Fine with me.
22	MS. YOHANNES: That's fine.
23	MS. FLETCHER: Mediation is set for
24	Tuesday, June 28 at 1:30. Any questions from
25	anyone?

1	MS. YOHANNES: None from the
2	applicant.
3	MS. LEWIS: No.
4	MS. FLETCHER: Well, thank you for
5	coming.
6	MR. KUPFER: Thank you very much.
7	MS. FLETCHER: I'll send out the WebEx
8	invitation. Thank you all. See you soon.
9	MS. YOHANNES: Thank you.
10	MS. LEWIS: Ms. Fletcher.
11	MS. FLETCHER: Yes.
12	MS. LEWIS: I have a question about
13	another case.
14	MS. FLETCHER: Is that you, Ms. Lewis?
15	MS. LEWIS: Yes, it is. Thank you.
16	Sorry.
17	MS. FLETCHER: Okay.
18	MS. LEWIS: It's about ABRA 120698.
19	I believe I mean, we have a settlement
20	agreement which is maybe why that's the reason
21	why they are not on the roll call for today.
22	MS. FLETCHER: What's the trade name?
23	MS. LEWIS: The trade name is Best One
24	Liquor.
25	MS. FLETCHER: That's not on the

1	calendar for today.
2	MS. LEWIS: Okay.
3	MS. FLETCHER: Maybe that's the
4	reason.
5	MS. LEWIS: Yes. Okay. I wasn't
6	sure.
7	MS. FLETCHER: It didn't make it to
8	the calendar so that could be the reason.
9	MS. LEWIS: Okay. Thank you.
10	MS. FLETCHER: That's it, Ms. Lewis?
11	MS. LEWIS: Yes.
12	MS. FLETCHER: Okay. Well, then I
13	will see you in a couple weeks.
14	MS. LEWIS: Okay. Thank you.
15	MS. FLETCHER: Thank you for coming.
