12 increase the occupancy be lowered from 499 to
13 600.

14 The next request, a request made by
15 Suite Shop, License Number 117995, they are
16 Retailer 25 percent and this is a new ABC license
17 application.

18 I therefore make a motion that ABC
19 Boards grants the requests by the 13 applicants
20 that were just read into record. Is there a
