MS. FLETCHER: We have one more case on the calendar, which is Apero. This is case no. 22-PRO-00047, Goth Wine Limited Liability Company. 2622 P Street NW. License no. ABRA-116925. This is a Retailer Class CR, license renewal. The protest issues are adverse impact on peace, order, and quiet. Is anyone present on behalf of Apero? Ms. Benchimol? I can see that you're there, but I can't hear you, though.

MS. BENCHIMOL: Sorry, I'm having some technical issues. Yeah, I'm here for Goth Wine, LLC. I didn't hear what the starting name was. Sorry.

MS. FLETCHER: Okay. Could you spell your name for the record, please.

MS. BENCHIMOL: Yeah. It's Ellizabeth Benchimol. E-L-L-I-Z-A-B-E-T-H. And Benchimol's B-E-N-C-H-I-M-O-L.

MS. FLETCHER: Thank you. Is anyone present on behalf of the Citizens Association of Georgetown?

MS. CRUSE: Yes, I am. Karen Cruse. K-A-R-E-N, C-R-U-S-E.

1	MS. FLETCHER: Thank you, Ms. Cruse.				
2	Ms. Cruse, I have a question for you. Did the				
3	Citizens Association of Georgetown inform the				
4	Applicant of the meeting that you held concerning				
5	the application with at least a seven-day notice?				
6	Do you know?				
7	MS. CRUSE: Yes, I did. I called the				
8	name on the placard, yes.				
9	MS. FLETCHER: Okay. Thank you.				
10	Thank you very much. Ms. Benchimol, would you				
11	agree with that?				
12	MS. BENCHIMOL: I was never called,				
13	but I was notified via email by my landlord.				
14	MS. FLETCHER: Say that again.				
15	MS. BENCHIMOL: I was notified via				
16	email by my landlord. Nobody ever called me,				
17	though.				
18	MS. FLETCHER: Okay. But you were				
19	aware of the meeting held regrading the				
20	application?				
21	MS. BENCHIMOL: Yes.				
22	MS. FLETCHER: Okay. Thank you.				
23	Okay. The Citizens Association of Georgetown is				
24	the only protestant in this matter, but I'll just				
25	note, for the record, there were four other				

protestants, actually. There were three abutting property owners. And there was a group of five. Those groups withdrew their protests prior to roll call today. So the Citizens Association is the only protestant in this matter.

MS. CRUSE: And, if I may jump in to short circuit this whole thing, I found out, recently, that the neighbors had worked out the issues with the Applicant and had withdrawn and, because of that, since they were the ones who were concerned about the establishment, we are fine with their withdrawal, and we are withdrawing our protest as well. And I will do that formally.

MS. FLETCHER: Okay. Thank you, Ms. Cruse. In that case, I'll just make a note of that, Ms. Cruse, and so we won't need to set any dates. So I will make a note that the Citizens Association has withdrawn its protest and that you'll send the withdrawal in writing. So, Ms. Cruse, I know you know what to do. You're going to send it to Martha Jenkins.

MS. CRUSE: Yes.

MS. FLETCHER: Okay. Any questions, Ms. Benchimol.
