11 follow the terms of the settlement agreement by
12 operating outside of its approved hours of
13 operation. Statutory authority D.C. code section
14 25-82386. This charge has been dismissed.

15 Charge three, the licensee failed to superintend
16 in person, or keep a licensed ABC manager on duty
17 at all times. Statutory authority D.C. code
18 section 25701, and 23DCMR section 707.1.

19 There will be a fine of 2000 dollars
20 to be paid within 120 days, or the license will
21 be suspended until the fine has been paid. Is
22 there a second?
