3 CHAIRPERSON ANDERSON: All right, the
4 next case on our calendar is Case Number 20-251-
5 00034, Angolo Ristorante Italiano, License Number
6 109417. Ms. Andrews, can you please elevate the
7 rights of the parties for this case please?

8 MS. ANDREWS: Sure, Mr. Chair, this is
9 a call in, what's his name? Mr. Jamal Bouzid,
10 I'm going to unmute his line.

11 CHAIRPERSON ANDERSON: Okay, thank
12 you.

13 MS. ANDREWS: Okay Mr. Jamal, you can
14 announce yourself please.

6 Georgetown LLC.

7 CHAIRPERSON ANDERSON: All right, good
8 morning sir. Mr. Ortiz, are there any
9 preliminary matters for this case?

10 MR. ORTIZ: There are no preliminary
11 matters at this time, the parties do not have an
12 offer in compromise to present to the board.

13 CHAIRPERSON ANDERSON: All right,
14 thank you. Mr. Bouzid, and Mr. Ortiz, this
15 matter then is scheduled for Show Cause Hearing
16 on August 4th, at 1:30. So August 4th, at 1:30
17 is when we'll have the hearing. So, if you have
18 a defense in the sense that you have documents,
19 and witnesses, that is when you can bring those,
20 they can appear at the hearing. One of the
21 things that I'm asking both parties to do, seven
22 days before August 4th I need you to exchange
23 documents and witnesses that you will be relying
24 upon at the hearing.

25 If you do not understand how to do

1 that sir, please contact the agency, and the
2 agency will let you know, will give you some
3 directions, and instructions how to do that. Do
4 you understand sir?

5 MR. BOUZID: Yes sir.

6 CHAIRPERSON ANDERSON: So August 4th
7 at 1:30, that's when you can give your defense of
8 this infraction, okay?

9 MR. BOUZID: Thank you so much.

10 CHAIRPERSON ANDERSON: All right, have
11 a great day, thank you very much.

12 MR. BOUZID: Thank you, bye.
