3 MS. FLETCHER: Okay, good morning,
4 everybody. Now, we're ready.

5 We are now live streamed to YouTube.

6 Thanks, everyone, for participating in
7 ABRA's Roll Call Hearings via the WebEx platform
8 provided by the D.C. Office of Open Government.

9 There are two cases on the calendar
10 today.

11 The first one is Bozzelli's Italian
12 Deli, 3000 K Street, Northwest. License Number
13 ABRA 118868, Retailer Class DR.

14 This is a substantial change for a
15 summer garden with 12 seats.

16 The protest issues are adverse impact
17 on peace, order, and quiet.

18 My name is LaVerne Fletcher conducting
19 the Roll Call Hearing as the Board's Agent.

20 Is anyone present on behalf of
21 Bozzelli's?

23 MS. FLETCHER: Is anyone present on
24 behalf of ANC 2E?

25 (NO AUDIBLE RESPONSE)

1 MS. FLETCHER: I'm going to recall
2 this case in about ten minutes.

3 (Whereupon, the above-entitled matter
4 went off the record at 10:04 a.m. and resumed at
5 10:12 a.m.

6 MS. FLETCHER: I'm recalling
7 Bozzelli's Italian Deli. Is anyone present on
8 behalf of Bozzelli's?

9 (NO AUDIBLE RESPONSE)

10 MS. FLETCHER: Is anyone present on
11 behalf of ANC 2E?

12 (NO AUDIBLE RESPONSE)

13 MS. FLETCHER: The time is
14 approximately 10:15.

15 Neither the Applicant nor the
16 Protestant is present.

17 The application is dismissed as well
18 as the protest.

19 I would like to make a note for the
20 record that this case was originally on the
21 calendar for a Roll Call hearing on June the
22 26th, but was postponed until today because my
23 computer crashed that morning.

24 And so, the parties were notified and
25 given the option to reschedule the roll call to

1 later that day or the following day or today.

2 And so, the hearing was scheduled for
3 today which is the normal day on which Roll Call
4 Hearings are held.

5 Neither party responded to my emails
6 and I sent an email -- a WebEx invitation to all
7 parties to attend this hearing on June the 28th.

8 That's just for the record.

9 The Roll Call Hearing in this matter
10 is now concluded.

11 There are no other cases on the
12 calendar for today.

13 Thank you.
