3	MS. FLETCHER: I'm going to move on to
4	the next case on the calendar which is Champion
5	Kitchen, Case Number 23-PRO-00052, E and K, Inc.
6	trading as Champion Kitchen, 7730 Georgia Avenue,
7	Northwest, License Number ABRA 103055.
8	This is a Retailer Class CR for a
9	substantial change for an increase in occupancy
10	from 44 to 89.
11	My name is LaVerne Fletcher conducting
12	the Roll Call Hearing as the Board's Agent.
13	Is anyone present on behalf of
14	Champion Kitchen?
15	MR. KLINE: Yes, good morning.
16	Andrew Kline from the Veritas Law
17	Firm.
18	MS. FLETCHER: Mr. Kline, could you
19	spell you name and Veritas?
20	MR. KLINE: Sure.
21	Andrew, A-N-D-R-E-W, Kline, K-L-I-N-E,
22	the Veritas Law Firm, Veritas, V as in Victor, E-
23	R-I-T-A-S.
24	MS. FLETCHER: Thank you.
25	Is anyone present on behalf of ANC 4A?

1	MS. HOYTE: Yes, good morning.
2	My name is Joan Hoyte. I'm
3	representing ANC 4A in single member district
4	4A02.
5	My name is J-O-A-N, last name H-O-Y-T-
6	E.
7	Thank you.
8	MS. FLETCHER: Thank you very much,
9	Ms. Hoyte.
10	ANC 4A does have standing as a
11	Protestant.
12	We need to set a date for mediation,
13	a status hearing, and a Protest Hearing.
14	I'll give you dates for the Status and
15	Protest Hearing first.
16	MR. SALB: Excuse me, Ms. Fletcher?
17	MS. FLETCHER: Yes?
18	MR. SALB: My name is Micah Salb. I'm
19	the president of the Shepherd Park Citizens
20	Association.
21	We also filed objections.
22	MS. FLETCHER: You sure did, thank
23	you. I've got that right here. You did, thank
24	you.
25	So, the Shepherd Park Citizens

1	Association also filed a protest.
2	Mr. Salb, could you spell your name
3	for the record, please?
4	MR. SALB: Of course, first name is
5	Micah, M-I-C-A-H, last name is Salb, S as in Sam,
б	A-L-B as in boy.
7	MS. FLETCHER: Thank you.
8	The Shepherd Park Citizens Association
9	does have standing as a Protestant.
10	Now, I'll give the dates for the
11	hearings.
12	The Status Hearing is scheduled for
13	August the 9th. That's August the 9th at 10:30
14	a.m. for the Status Hearing.
15	The Protest Hearing is set for
16	September 13, that's 2023, at 1:30 p.m.
17	I will give you the next available
18	date for the
19	MR. SALB: Sorry, what was the
20	September 13th hearing?
21	MS. FLETCHER: The September 13
22	hearing is the Protest Hearing. September 13 at
23	1:30, that's for the Protest Hearing.
24	MS. HOYTE: What day is the 13th,
25	please?

1	MS. FLETCHER: A Wednesday.
2	MS. HOYTE: Okay, thank you.
3	MR. SALB: I have a conflict.
4	MS. FLETCHER: Ms. Hoyte, I'm just
5	for the court reporter, I'm sorry, I forgot to
6	ask to state your name before you speak so that
7	the court reporter knows who's speaking.
8	That was Ms. Hoyte asking about the
9	day of the hearing.
10	You were going to say something, Mr.
11	Salb?
12	MR. SALB: Yes, I believe that I have
13	conflict that week.
14	MS. FLETCHER: On which day?
15	MR. SALB: Sorry, the week of the 11th
16	of September.
17	MS. FLETCHER: What you can do is
18	petition the Board to reschedule that day.
19	The day that I'm giving you this
20	morning is the date that's available on their
21	calendar as of right now.
22	But you may petition the Board to
23	reschedule that date.
24	If you do that, you need to copy Mr.
25	Kline on your request. And if it's a joint

1	request, then you can submit a joint request.
2	But Mr. Salb, do you have Mr. Kline's
3	contact information?
4	MR. SALB: I don't know that I do.
5	Mr. Kline, have you entered an
6	appearance or filed any papers?
7	MR. KLINE: We filed the request.
8	MR. SALB: Okay, I
9	MR. KLINE: But I'm happy to get
10	I'm happy to send you an email with my contact
11	information.
12	MR. SALB: Either way is fine, you're
13	not that hard to locate.
14	MS. FLETCHER: The next available date
15	for mediation is Wednesday, July 12th any time
16	between 10:30 and 1:30.
17	MR. SALB: I'm available at any time.
18	This is Micah Salb.
19	MS. FLETCHER: Well, that's a
20	Wednesday, Mr. Kline, I don't know if you have
21	any other cases that day.

16	Monday, July 17th at 1:30. And I'll send you the
17	WebEx invitation.
18	Mr. Salb, you can, you know, petition
19	the Board through Martha Jenkins to request a
20	change in the Protest Hearing date.
21	Do you have Martha Jenkins' email
22	address, Mr. Salb?
23	MR. SALB: I do, yes.
24	MS. FLETCHER: Okay, thank you.
25	Okay, in that case, it appears that

1	the Roll Call Hearing is over unless anybody has
2	any questions.
3	MS. HOYTE: Can I ask, I do have Mr.
4	Kline's contact information.
5	Mr. Salb, will you please share,
6	perhaps by email, if you don't care to do it
7	here, your phone number where I can reach you?
8	MR. SALB: Oh, of course.
9	MS. HOYTE: Okay, thank you.
10	MR. SALB: I'll share that.
11	MS. HOYTE: And this is Joan Hoyte, I
12	forgot to mention that. I figured since I'm the
13	only other female on this call, it would reflect
14	that.
15	Thank you.
16	MS. FLETCHER: Well, I can see it, but
17	the court reporter can't.
18	MS. HOYTE: Yes, thank you.
19	MS. FLETCHER: Okay, well, thank you
