3 MS. FLETCHER: The next case on the  
4 calendar is Good Stuff Eatery, Case No. 22-PRO-  
5 00056, Sunnyside Group, LLC, 303 Pennsylvania  
6 Avenue, S.E., License No. ABRA-078027. This is a  
7 Retailer Class DR, License Renewal. The protest  
8 issues are adverse impact on peace, order, and  
9 quiet.

10 My name is Laverne Fletcher conducting  
11 the roll call hearing as the Board's agent. Is  
12 anyone present on behalf of the establishment?

13 MR. JACKSON: Yes, Jeff Jackson  
14 present.

15 MS. FLETCHER: Oh, good morning, Mr.  
16 Jackson.

17 MR. JACKSON: Good morning.

18 MS. FLETCHER: Mr. Jackson, would you  
19 spell your name for the record, please?

20 MR. JACKSON: J-E-F-F, J-A-C-K-S-O-N.

21 MS. FLETCHER: Thank you. Is anyone  
22 present on behalf of ANC 6B?

23 MR. READY: This is Brian Ready,  
24 Commissioner Ready, for ANC 6B, Chair of the ANC  
25 6B's ABC committee.

1 MS. FLETCHER: Thank you, Mr. Ready.  
2 Would you spell your name for the record, please?

3 MR. READY: The first name is Brian,  
4 B-R-I-A-N. Last name is Ready, R-E-A-D-Y.

5 MS. FLETCHER: Thank you. ANC 6B does  
6 have standing as a Protestant. We need to set a  
7 date for mediation, a status hearing, and a  
8 protest hearing.

9 I will give the dates of the status  
10 and protest hearing first. The status hearing is  
11 scheduled for August 10. That's August 10, 2022  
12 at 10:30 a.m. The protest hearing is scheduled  
13 for September 14, 2022 at 1:30.

14 I will give you the next available day  
15 for mediation. Let's see here. The next  
16 available day for mediation is Monday, July 25 at  
17 1:30 in the afternoon. Wednesday, Thursday, and  
18 Friday of that week are also available. But the  
19 next available day is Monday, July 25 at 1:30.

20 MR. JACKSON: Yeah, I'm available that  
21 day.

22 MR. READY: Okay. That's fine.

23 MS. FLETCHER: Is that good for you  
24 too, Mr. Ready?

25 MR. READY: Yes.

1 MR. JACKSON: And could you repeat the  
2 status date again, Ms. Fletcher?

3 MS. FLETCHER: Yeah. The status  
4 hearing is August 10, 2022 at 10:30 a.m.

5 MR. JACKSON: Thank you.

6 MS. FLETCHER: You're welcome. So  
7 mediation is set for Monday, July 25 at 1:30.  
8 And I will send you the Webex invitation to  
9 attend.

10 MR. READY: Perfect.

11 MS. FLETCHER: Any questions at all?  
12 I'll see you then. Thank you for coming.

13 MR. JACKSON: Thank you.
