3 CHAIRPERSON ANDERSON: The next case
4 in our calendar is Case No. 22-CMP-00088,
5 Georgetown Inn West End/Casta's Rum Bar, License
6 No. 109462. Mr. Orellana, can you please elevate
7 the Licensee in this case please?

8 MR. ORELLANA: Cameron Mixon, your
9 access has been elevated. That appears to be
10 all, Chairman.

11 CHAIRPERSON ANDERSON: Thank you. Mr.
12 Mixon.

13 MR. MIXON: Mr. Chairman, I am in the
14 process of turning my camera on. I'm not sure if
15 it's visible to you.

16 CHAIRPERSON ANDERSON: It's not, sir.

17 MR. MIXON: It appears my computer is
18 not fully cooperating, but I have been present
19 and I am here as counsel to the Licensee.

18 show cause hearing on August 2nd, 2023 at 10:30
19 a.m. I just want to remind both parties that
20 seven days before the hearing you are required to
21 disclose documents and witnesses that will be
22 relied upon at the hearing. Failure by either
23 side to disclose documents and witnesses, the
24 Board is empowered to prevent that side from
25 relying on documents and witnesses that have not

1 been disclosed seven days prior to the hearing
2 unless good cause has been shown. Any questions?

3 MR. MIXON: None at this time.

4 CHAIRPERSON ANDERSON: All right.

5 Well, thank you very much. Have a great day.
