3 CHAIRPERSON ANDERSON: All right. The
4 next case in our calendar is Case No. 23-CMP-
5 00036, Johnn's All-American, License No. 123033.
6 Mr. Orellana, can you please elevate the rights
7 of the Licensee in this case please?

8 MR. ORELLANA: Sure. Brandon Givand,
9 your access has been elevated. That is all,
10 Chairman.

11 CHAIRPERSON ANDERSON: Thank you.
12 Okay. Mr. Givand (audio interference)--

13 MR. GIVAND: Diana Givand.

14 CHAIRPERSON ANDERSON: All right.
15 Okay, so can both of you turn your cameras on
16 please? Sorry. I see you, Mr. Givand and I
17 guess I'll wait for Diana Givand to turn her
18 camera on.

19 MS. GIVAND: Thank you.

20 CHAIRPERSON ANDERSON: All right, good
21 morning. All right. Mr. Celo, can you please
22 identify yourself for the record please?

23 MR. CELO: Anthony Celo, A-N-T-H-O-N-Y
24 C-E-L-O on behalf of the District.

25 CHAIRPERSON ANDERSON: Mr. Givand, can

1 you please spell and state your name for the
2 record and your affiliation?

3 MR. GIVAND: It's Brandon, B-R-A-N-D-
4 E-N Givand, G-I-V-A-N-D, affiliated as a cook,
5 bartender, general manager, security, marketing,
6 janitorial, and owner.

7 CHAIRPERSON ANDERSON: Well, I think
8 I heard all the other titles, Mr. Givand, which
9 were not important for my purpose. The only
10 title that I really wanted to hear was that
11 you're the owner. That's the part of it because
12 --

13 MR. GIVAND: I was just being silly,
14 Mr. Anderson because -- you know, I didn't get to
15 see Mr. Mixon's top.

16 CHAIRPERSON ANDERSON: Mr. Givand, for
17 attorneys, sir, I require attorneys, not for non-
18 attorneys, that they need to dress what I -- to
19 wear a jacket to participate in these hearings.
20 Non-attorneys, sir, you're fine. And I also ask
21 virtually that I need to see who I'm talking to
22 because if we're meeting in-person, you would
23 have to -- you would have to appear before me at
24 the desk. So I'm just asking both -- all parties
25 to -- if you had to show up in-person, because

1 we're virtual, I need you to behave and dress the
2 same way. All right, sir? So that's -- that's
3 my running joke with the -- with the attorney
4 from before. Okay?

5 Ms. Givand, can you please spell and
6 state your name for the record please?

7 MS. GIVAND: Diana Gavand, D-I-A-N-A,
8 last name G-I-V-A-N-D, affiliated as a co-owner
9 and counsel.

10 CHAIRPERSON ANDERSON: All right,
11 thank you. All right, Mr. Celso, are there any
12 preliminary matters in this case please?

13 MR. CELO: None from the District. I
14 would note that settlement negotiations are
15 ongoing, but have not yet resolved.

16 CHAIRPERSON ANDERSON: Okay. Any
17 preliminary matters on the part of -- on the part
18 of the Licensee?

19 MS. GIVAND: None on behalf of the
20 Licensee.

21 CHAIRPERSON ANDERSON: All right,
22 thank you. All right. This matter then is
23 scheduled for a show-cause hearing on August 9th,
24 2023 at 10:30 a.m. I just want to remind the
25 parties that seven days before the hearing, you

1 are required to exchange documents and witnesses
2 that will be relied upon at the hearing. Failure
3 by either side to provide documents and witnesses
4 seven days prior to the hearing, the Board is
5 empowered to prevent them from relying on these
6 documents unless good cause has been shown. Any
7 questions?

8 MR. CELO: None from the District.

9 CHAIRPERSON ANDERSON: All right.

10 Then I will see you then on August 9th at 10:30
11 for this hearing. Thank you very much. Have a
12 great day.
