3 MS. FLETCHER: The next case is
4 Southern Express Liquors. Southern Express.
5 This is Case Number 21-PRO-00045, SIEM
6 Incorporated, 4416 Southern Avenue Southeast,
7 License Number ABRA-108607. This is a Retailer
8 Class A License renewal. The protest issues are
9 adverse impact on peace, order, and quiet.

10 Who is present on behalf of Southern
11 Express? Is anyone present on behalf of Southern
12 Express?

13 (Pause.)

14 MS. FLETCHER: Is anyone present on
15 behalf of Southern Express?

16 (Pause.)

17 MS. FLETCHER: The license renewal
18 application of Southern Express is dismissed
19 because the Applicant is not present.

20 Who is present on behalf of ANC 7E?

21 MS. TIERA FLETCHER: Hi. This is
22 Commissioner Tiera Fletcher for ANC 7E.

23 (Simultaneous speaking.)

24 MS. TIERA FLETCHER: -- and Chair of
25 7E.

1 MS. FLETCHER: Thank you, Ms.
2 Fletcher. Ms. Fletcher, would you spell your
3 name for the record?

4 MS. TIERA FLETCHER: Yes. Tiera
5 Fletcher, T as in tree, I as in igloo, E as in
6 elephant, R as in road, A as in apple. Fletcher,
7 F as in Frank, L as in last, E as in elephant, T
8 as in tree, C as in car, H as in house, E as in
9 elephant, R as in road.

10 MS. FLETCHER: Thank you, Ms.
11 Fletcher. Ms. Fletcher, because the Applicant is
12 not present today, that means that the
13 application is dismissed. What happens next is
14 the Applicant and you will receive a copy of a
15 Board order dismissing the application because
16 the Applicant failed to appear.

17 The Applicant will have an opportunity
18 to seek reinstatement of the application
19 explaining to the ABC Board why they were not
20 present today. If they do seek reinstatement of
21 the application, you'll have an opportunity to
22 respond to that.

23 MS. TIERA FLETCHER: Okay. And I will
24 receive email notification, and if they do
25 respond, then it -- it restarts the process, roll

2 MS. FLETCHER: Well, it depends on
3 what the Board decides. So the Board will have
4 to decide whether or not to reinstate the
5 application. But -- so -- so the -- the Board
6 order will let you know what's going to happen
7 next in this case.

8 MS. TIERA FLETCHER: Okay.

9 MS. FLETCHER: But you are going to
10 get a copy of the Board order dismissing the
11 application because the Applicant is not here
12 today, and then you'll be kept informed along the
13 way --

14 MS. TIERA FLETCHER: Okay. Thank you.

15 MS. FLETCHER: -- about what happens
16 next. Any other questions, Ms. Fletcher?

17 MS. TIERA FLETCHER: I don't think
18 there's any other renewals on today's roll call
19 hearing --

20 (Simultaneous speaking.)

21 MS. FLETCHER: For 7E? Let me see.
22 No, there -- this is the only thing for 7E today.

23 MS. TIERA FLETCHER: Okay. Thank you.
24 Have a great day.

25 MS. FLETCHER: I'm -- I'm glad you got

1 through.

2 MS. TIERA FLETCHER: Okay. Thank you.

3 MS. FLETCHER: Okay.

5 Southern Express Liquors is concluded.
