3 CHAIRMAN ANDERSON: Castas. Okay. The
4 next case then is case no. 22-PRO--00033, 1942
5 DC, License No. 70728. And I guess this is the
6 case that Mr. Orlaskey is, needs to elevated. So
7 Ms. Fashbaugh can you please elevate Mr. Orlaskey
8 for this case, please?

25 CHAIRPERSON ANDERSON: Good morning,

21 And also because this, these hearings
22 are now virtually, your, the hearing, you'll have
23 one hour to present to your case. And you can
24 call no more than five witness.

2 MS. YOHANNES: None for the applicant.

3 CHAIRPERSON ANDERSON: And if you have
4 any questions --

5 MR. ORLASKEY: I do have one question.

6 CHAIRPERSON ANDERSON: Yes,

7 Mr. Orlaskey, go ahead, sir.

8 MR. ORLASKEY: I have two status
9 hearings today. I didn't catch which one this

11 CHAIRPERSON ANDERSON: For 1942.

12 MR. ORLASKEY: 1942, okay. All right,
13 thank you.

14 CHAIRPERSON ANDERSON: All right. All
