LEE: Good morning, sir. 7 CHAIRPERSON ANDERSON: Good morning, 8 Mr. Holmes. Can you please spell and state your name for the record? 9 10 MR. HOLMES: A-N-T-A-W-A-N, Holmes, H-11 O-L-M-E-S. Chair, ANC 7C. 12 CHAIRPERSON ANDERSON: Good morning, 13 Are there any preliminary matters in this sir. case? Mister -- start with Mr. Lee. 14 15 Any problems, any concerns. Not 16 substantive but just any problems, any concerns 17 that you have, sir. 18 Not really, sir. MR. LEE: It's my 19 first time being here. And then, I'm trying --20 I'm still learning things. So, I don't really 21 have any questions at the moment. 2.2 CHAIRPERSON ANDERSON: Okay, that's 23 fine. Mr. Lee? I'm sorry. Mr. Holmes? 2.4 MR. HOLMES: Thank you. So, ANC 7C, 25 on our special meeting on July the 11, did vote

1 to approve the -- to approve this, upon the 2 completion of the settlement agreement. We have a -- we have a draft settlement agreement from 3 Mr. Lee. We will be reviewing it, actually, 4 5 later today, after this meeting. So, it's still 6 moving ahead towards the settlement. 7 CHAIRPERSON ANDERSON: All right. So, 8 it appears that -- okay. That's great. It's 9 good to hear that the parties --10 MR. HOLMES: Thank you, Mr. Lee. 11 CHAIRPERSON ANDERSON: -- have a 12 settlement agreement that probably will be 13 approved. And what I will ask the parties to do 14 is, as soon as the settlement agreement has been 15 approved, please provide this to the Agency as 16 soon as possible. If this matter -- so, if it's -- so, 17 18 as you said, Mr. Holmes, if you discuss it today 19 and you believe that -- are you having an ANC 20 meeting today or, when is your next meeting? 21 MR. HOLMES: We had our special July 2.2 meeting for ABRA, for ABCA, last Thursday. So, 23 we've gone through all of the cases. At this 24 point, it's all about -- it's, for every one of 25 them, it's a finalization of the settlement

1 agreements. They're all -- most of them are in 2 We've already submitted a few already, draft. 3 that you've stated earlier today. CHAIRPERSON ANDERSON: 4 Okay, that's 5 fine. So, if you meet today, you could 6 conceivable provide a copy of it to the Board, to 7 say that -- to the Agency, to say this case has 8 been settled? That's what I'm just trying to find --9 10 (Simultaneous speaking.) 11 MR. HOLMES: Absolutely, yes. That is 12 what we're working towards. Mr. Lee has been 13 very forthcoming to the community and addressing 14 everything. We just need to finish the document. 15 We just need more time, that's all. 16 CHAIRPERSON ANDERSON: All right, 17 thank you. All right, if this matter is now 18 settled, which it appears that it will be 19 settled, then is scheduled for a protest hearing 20 on September the 11th at 1:30 p.m. 21 Just want to let you know, that if 2.2 this matter goes to a protest hearing, seven days 23 prior to the hearing, the parties are required to 24 provide -- to exchange -- to do a PIF to -- and 25 provide -- exchange the document to each other,
