25 authority DC Code Section 25 781, DC Code Section

1 25 823(a)(1). There is a fine of \$2,000 payable
2 within 60 days of the Board accepting the OIC.
3 If payment is not made within 60 days, the
4 license will be suspended until the payment has
5 been made.

6 Charge 2, suspension. The license
7 will be suspended for five days with all five
8 days stayed for one year pending no further
9 violations in that time.

10 Charge -- I'm sorry. Term number 3,
11 completing alcoholic awareness training for all
12 employees who serve alcoholic beverages within 90
13 days from the date of the Board order approving
14 the OIC.

15 Charge 2, failure to take reasonable
16 steps to ascertain legal drinking age. The
17 statutory authority, DC Code Section 25 783.
18 This charge is dismissed.

19 Is there a second?

23 suspended until the fine has been paid.

24 Charge Number 2, establishment used
25 for unlawful purpose. Statutory authority, DC

1 Code Section 25 823(a)(2). There is a fine of
2 \$2,000 to be paid within 120 days or the license
3 will be suspended until the fine has been paid.

4 Charge 3, violated the Board's Public
5 Health Emergency Rule. Statutory Authority, 23
6 DCMR Section 810.2, DC Code Section 25 823(a)(1).
7 There's a fine of \$1,000 to be paid within 120
8 days or the license will be suspended until the
9 fine has been paid.

10 Therefore, the total fine of \$5,000 to
11 be paid within 120 days -- the fine has not been
12 paid. The license will be suspended. Is there a
13 second?
