3 MS. FLETCHER: The next case on the
4 calendar is Foxtrot. This is Case No. 23-PRO-
5 00057, Foxtrot Retail DC, LLC, 1827 Adams Mill
6 Rd. Northwest, License No. ABR-A-124611. This is
7 a Retailer Class CR, new license application.

8 MR. MIXON: Hello, Ms. Phyllis - Ms.
9 Fletcher, I'm sorry. Cameron Mixon on behalf of
10 the applicant.

11 MS. FLETCHER: Mr. Mixon, thank you
12 very much. Mr. Mixon, could you spell your name
13 for the record, please?

14 MR. MIXON: Cameron, C-A-M-E-R-O-N,
15 Mixon, M-I-X-O-N.

16 MS. FLETCHER: Thank you.

17 The protest issues in this matter are
18 adverse impact on peace, order, quiet. My name
19 is Laverne Fletcher conducting the roll call
20 hearing as the Board's agent.

1 communication with the Kalorama Citizens

3 MR. MIXON: Not personally. My firm
4 has in receipt of their protest letter, but I
5 have yet to engage in a session with them on the
6 matter.

7 MS. FLETCHER: Okay, thank you. The
8 time is approximately 10:27 a.m. The Kalorama
9 Citizens Association is not present, therefore
10 the protest filed by the KCA is dismissed.

11 What that means, Mr. Cameron, is that
12 the Board will issue an order dismissing the
13 protest because the KCA is not present. If they
14 seek reinstatement - well, you'll receive a copy
15 of the order - if they seek reinstatement, we'll
16 let you know that as well.

17 And you would have an opportunity to
18 respond to that.

19 MR. MIXON: Understood. Ms. Fletcher,
20 I was just on the ABCA website for the meeting
21 agendas and there's not currently one posted for
22 July the 24th, so I was just wondering if there
23 was anything else on the agenda today?

24 MS. FLETCHER: There's another case in
25 the matter of Foxtrot on the agenda today. And

1 that is the last case on the roll call hearing
2 calendar today. The second Foxtrot case that I'm
3 about to call, is there anyone in particular that
4 you were concerned about?

5 MR. MIXON: No, just looking to see if
6 there were any I wasn't aware of because it's not
7 on the website.

8 MS. FLETCHER: You didn't see it on the
9 website?

10 MR. MIXON: Yes.

11 MS. FLETCHER: Okay, thanks for
