3 CHAIRPERSON ANDERSON: The next case on
4 my calendar is Case Number 22-CMP-0031, Exiles.
5 License Number 102051. Ms. Fashbaugh, can you

6 Compromise was communicated to the establishment
7 but I see that it was not communicated to Ms.
8 Yohannes. So, I will inform the assigned
9 attorney for this case to communicate directly
10 with her.

11 CHAIRPERSON ANDERSON: Thank you.

12 MS. YOHANNES: I'll just state for the
13 record I am aware. We said this morning we will
14 continue communications going forward.

15 CHAIRPERSON ANDERSON: All right.
16 Thank you, ma'am.

17 All right. Then this matter is
18 scheduled for a Show Cause Hearing on August 31,
19 2022, at 10:30 a.m. I just want to remind the
20 parties that if this matter goes to a hearing
21 seven days prior to the hearing the parties are
22 required to disclose documents and witnesses. If
23 documents and/or witnesses are not disclosed, the
24 Board is empowered not to allow the other party
25 to move forward with documents and witnesses

1 unless good cause is shown why that hasn't been
2 accomplished. Any questions by anyone?

3 MS. YOHANNES: None for us.

4 MR. CENCI: Thank you.

5 CHAIRPERSON ANDERSON: All right.

6 Thank you. Have a great day then, thank you.

7 MS. YOHANNES: Thank you.
