3 CHAIRPERSON ANDERSON: The next case
4 in our calendar is just a fact-finding hearing
5 and this is on Aslin Beer Company, license number
6 118555.

7 Ms. Andras, can you please elevate the
8 rights of the licensee and any of the parties?

9 I believe that Angela Klein is the
10 attorney, the licensee, and there might be an
11 investigator. Please elevate their rights.
