And these exchanges are 11 12 between the parties, and ABRA legal should also 13 be provided a copy. And each side will have no 14 more than five witnesses, and you have 60 minutes 15 to present your case. If the parties are able to settle this 16 17 matter, the Board supports settlement, so we look 18 forward to that.
