2 Commissioner for ANC 3E05.

3 CHAIRPERSON ANDERSON: I apologize,

6 a protest hearing, seven days before the hearing  
7 you are required to exchange PIF. These  
8 documents must be provided to the other side and  
9 also ABRA legal, and you are limited to five  
10 witnesses and you have one hour to present your  
11 case.

12 I wish you good luck in your  
13 negotiations. If this matter is not settled,  
14 then we will see you on September 21st at 1:30  
15 for the protest hearing.

16 Thank you very much for being here  
17 today. Have a great day.

18 MS. YOHANNES: Thank you.

19 MS. GIANINNO: Thank you.

20 CHAIRPERSON ANDERSON: All right.
