FLETCHER: The next case on the 4 calendar is Hornblower Cruises and Events, LLC 5 trading as Odyssey Cruises, case no. 22-PRO-6 00077, 600 Water Street SW, #D, license number 7 ABRA 022107. This is a retailer class C marine 8 vessel license renewal. The protest issues are 9 adverse impact on peace, order, and quiet. Who 10 is present on behalf of the Applicant, please? 11 I am, Ms. Fletcher. MR. MINORA: 12 name is Matthew Minora from the Law Firm of 13 Mallios, O'Brien, and Sandground. M-A-T-T-H-E-W 14 M-I-N-O-R-A. 15 MS. FLETCHER: Mr. Minora, would you spell O'Brien and Mallios? 16 17 MR. MINORA: Sure. Mallios is M-A-L-18 L-I-O-S. O'Brien is O apostrophe B-R-I-E-N. 19 MS. FLETCHER: Thank you, very much. 20 Present on behalf of ANC 6D? 21 MR. DANIELS: Edward Daniels, Chair 22 ANC 6d. Edward, E-D-W-A-R-D, Daniels, D-A-N-I-E-L-S. 23 24 Thank you, Mr. Daniels. MS. FLETCHER:

The status hearing has been scheduled 17 for September 28 at 10:30, the protest hearing has been scheduled for October 26 at 1:30. 18 19 there are no questions in this matter, the roll 20 call hearing in this matter is concluded. 21 Thank you, Ms. Fletcher, MR. MINORA: 22 and if I could just ask a question while Chair 23 Daniels is here. I was just wondering if the 24 Gordon Ramsey Fish and Chips establishment will 25 be handled at a later roll call date.

MR. MINORA: I was just inquiring about the status of the license applicant GRNA FC of DC, LLC, license number 121423. I just wasn't sure if that was supposed to be included in this hearing or if it's going to be dealt with at a later date.

MS. FLETCHER: Well, it was supposed

to be included with this hearing, yes. 1 But, Mr. 2 Minora, any particular reason why you were 3 thinking it would be at a later date? 4 MR. MINORA: I didn't see it on this 5 updated calendar, so that's what I wanted to do 6 is make sure it didn't administratively get mixed 7 because there are a lot of similarly named 8 applicants all at the same time and similar 9 addresses. 10 MR. DANIELS: I'm sorry, Ms. Fletcher. 11 I know that -- I'm sorry, go ahead. 12 MS. FLETCHER: I'm sorry. I'm going 13 to answer Mr. Minora's question. So, Mr. Minora, 14 the calendar was updated at the very last minute. 15 So, it's on there now, and I sent an updated 16 calendar to you and Mr. Daniels, but it was at 17 the very last minute so you may not have seen it 18 yet. 19 MR. MINORA: Okay. Sorry about that, 20 then. 21 That's okay. I sent it MS. FLETCHER: 22 at the very last minute because you know this all 23 happened at the last minute. So, you'll see a 24 copy of it. Mr. Daniels, what were --25 MR. DANIELS: Thank you. I also quess

I didn't see the update as well. But, yeah, I 1 2 know that that one, if there was a protest, we 3 will be withdrawing that protest as well because 4 we voted to support that license application. 5 Okay. I'm going to go MS. FLETCHER: back to that case, and I'm going to make a note 6 7 of that, Mr. Daniels. That is one that you intend to withdraw? 8 9 MR. DANIELS: Yes. MS. FLETCHER: I have made a note of 10 11 So, that mediation is set for September 6 12 at 1:30 and will, of course, be cancelled once we receive the withdrawal. 13 14 MR. MINORA: To be clear, I'm not 15 talking about the Hell's Kitchen application that 16 we discussed earlier. I'm talking about the 17 Gordon Ramsey Fish and Chips application. 18 MR. DANIELS: So, Ms. Fletcher, I'm 19 sorry. MS. FLETCHER: 20 I thought that was it. 21 MR. DANIELS: No, that was Hell's 22 Kitchen. I don't see Fish and Chips on the 23 updated schedule that you sent out. Okay. 24 MS. FLETCHER: Because,

17	withdrawing the protest today as well.
18	MS. FLETCHER: I'm just going to make
19	a note of that. And that's Gordon Ramsey, right?
20	MR. DANIELS: Yes. Correct.
21	MS. FLETCHER: So, if you do that it
22	won't make it to a roll call hearing calendar.
23	I've made a note that that withdrawal is coming.
24	MR. DANIELS: Yes. Thank you. And,
25	Matt, I will make sure to copy you on all of

1	these withdrawal letters as well.
2	MR. MINORA: Thank you, so much. I
3	appreciate it.
4	MS. FLETCHER: Mr. Minora, thanks for
