3 MS. FLETCHER: The next case on the
4 calendar is Hornblower Cruises and Events, LLC,
5 case no. 22-PRO-00078, 600 Water Street SW,
6 license number ABRA 077414. This is a retailer
7 class C marine vessel, license renewal. For
8 administrative convenience, four vessels, four
9 establishments have been named under case no. 22-
10 PRO-00078. Those four vessels are trading as
11 Spirit of Mt. Vernon, trading as Spirit of
12 Baltimore II, trading as The Capital Elite,
13 trading as National Elite.

14 Ms. Cruse?

15 I hear a lot of talking in the
16 background. I can't tell where it's coming from,
17 but I'm just going to proceed. Mr. Minora and
18 Mr. Daniels, can you hear me?

19 MR. DANIELS: Yes.

20 MR. MINORA: Yes. Thank you.

21 MS. FLETCHER: The address for these
22 establishments are 600 Water Street SW, license
23 renewal. The protest issues are adverse impact
24 on peace, order, and quiet. My name is Laverne
25 Fletcher conducting the roll call hearing as the

1 Board's agent. Who is present on behalf of the
2 establishment?

3 MR. MINORA: I am, Ms. Fletcher.
4 Matthew Minora from the Law Firm of Mallios,
5 O'Brien, and Sandground. M-A-T-T-H-E-W M-I-N-O-
6 R-A.

7 MS. FLETCHER: Mr. Minora, can you
8 spell O'Brien and Mallios?

9 MR. MINORA: Sure. Mallios is M-A-L-
10 L-I-O-S and O'Brien is O apostrophe B-R-I-E-N.

11 MS. FLETCHER: Thank you. Present on
12 behalf of ANC 6D?

13 MR. DANIELS: Yes, Edward Daniels,
14 chair ANC 6D. E-D-W-A-R-D D-A-N-I-E-L-S.

15 MS. FLETCHER: What's happening with
16 these, Mr. Daniels?

17 MR. DANIELS: Yes. This is the last
18 one here, so we will also be withdrawing this
19 protest today.

20 MS. FLETCHER: Okay. Thank you, very
21 much. I will go ahead, then, and just add this
22 mediation to the others scheduled for August 18
23 at 1:30 just to keep them all together.

24 MR. DANIELS: Okay. Thank you.

25 MS. FLETCHER: Mr. Minora, is that

1 okay with you?

2 MR. MINORA: Yes. Thank you.

3 MS. FLETCHER: I will go ahead and
4 give you the status and protest hearing dates for
5 those. The status hearing is September 28 at
6 10:30. The protest hearing is October 26 at
7 1:30. Mr. Minora and Mr. Daniels, those are all
8 of the cases that you have on the calendar today.

9 MR. MINORA: Thank you, so much.

10 MR. DANIELS: Thank you.

11 MS. FLETCHER: Thank you for coming.
12 So, Mr. Daniels, we'll just be on the lookout for
13 the withdrawals and then we'll get everything
14 taken care of.

15 MR. DANIELS: Yes. I'll get those
16 over to you today. Thank you.

17 MS. FLETCHER: Okay. Thank you.
18 Anything, Mr. Minora?

19 MR. MINORA: Nope. I think that's it.
20 Thanks, so much.

21 MS. FLETCHER: Okay. Thank you, very
22 much. Have a nice day. The roll call hearing is
23 concluded.
