21	Assistant Attorney General Bisola Oni.

MANTRI: So I don't have any information other than the citation that I had to 6 7 be here at 10:30 for the hearing. CHAIRPERSON ANDERSON: All right. 8 9 Then, Ms. Brown, can you make sure that Ms. Oni 10 provides -- or can you provide Mr. Mantri 11 Ms. Oni's contact information, please? 12 MS. BROWN: Sure. Or perhaps it would 13 be easier if he could provide his email address 14 for her to contact, because I know that she 15 reached out to the establishment but hadn't received a response. 16 17 CHAIRPERSON ANDERSON: Mr. Mantri, 18 what -- can you put your contact information in 19 the chat? 20 MR. MANTRI: Sure. 21 CHAIRPERSON ANDERSON: And then -- and 2.2 the reason is this is on -- this is on YouTube, 23 so it -- if you put it in the chat, there's some 2.4 privacy there rather than saying it out loud. 25 can you please put your contact information in

the chat, and Ms. Brown will ensure that Ms. Oni has that, so, therefore, there can be communication between the two parties.

MR. MANTRI: Sure. I just sent my email address to -- to Brown, Ms. Brown. Hope she got that in the chat.

CHAIRPERSON ANDERSON: All right.

MS. BROWN: Yes. That is actually the email we have on record. So I'll have Ms. Oni follow up with the establishment.

CHAIRPERSON ANDERSON: So you're saying that you have not received any contact from the government?

MR. MANTRI: When you say "not contact," what does that mean? Sorry. Again, understand this is the first time I'm here. I don't have any clue other than I had to be here to -- to be -- on the hearing for the citation that I got.
