3 CHAIRPERSON ANDERSON: We're on the
4 record. Good afternoon, everyone. Welcome to
5 the afternoon session of the ABC Board. My name
6 is Donovan Anderson. I'm Chairman of Board.
7 Joining me this afternoon are three of the Board
8 Members. We have Ms. Rafi Crockett, Mr. James
9 Short, and Mr. Edward Grandis. The Board has
10 four members for attendance and that constitutes
11 a quorum.

12 We have for this afternoon's calendar
13 eight cases on our calendar. Before we get
14 underway with this hearing, I need to make a few
15 instructions very clear for the conduct of these
16 hearings.

17 Once a case is called, I will take a
18 moment for our IT Specialist to elevate the
19 rights of each party to enable their camera and
20 equipment. Then, and only then, will we have the
21 ability to enable your equipment. If your case
22 has not been heard, you will remain muted and the
23 camera will be disabled.

24 At the conclusion of each case the
25 parties will have the option to leave. All

1 cameras and microphones for the concluded cases
2 will be disabled. If you have any questions or
3 require any assistance during the hearing, please
4 submit them using the question and answer
5 feature.

6 We're going to call our afternoon
7 cases but I'm going to call them out of order in

10 The first case we'll be called this
11 afternoon is Case No. 22-CM-00034, Cafe Citron,
12 License No. 60138. This case has been cancelled.
13 The Board approved an Offer in Compromise. See
14 Board Order No. 2022-579.
