3	CHAIRPERSON ANDERSON: Good afternoon,
4	everyone and welcome, we're on the record,
5	welcome to our afternoon session of the ABC
6	Board. My name is Donovan Anderson, I'm Chairman
7	of the Board.
8	Joining us this afternoon are Mr.
9	James Short, Mr. Bobby Cato, Ms. Rafi Crockett,
10	Ms. Jeni Hansen and Mr. Edward Grandis. The
11	Board has six members in attendance for the
12	conduct of business and that constitutes a
13	quorum.
14	All right, before we get underway with
15	this afternoon's agenda, I need to make a few
16	instructions very clear so that the conduct of
17	this hearing is understood by everyone. There
18	are four hearings scheduled for this afternoon.
19	Once your case is called, I will take
20	a moment for our IT Specialist to elevate the
21	rights for each party, to enable their camera and
22	microphone. Then, and only then, will you have
23	the ability to enable your equipment.
24	If your case is not being heard, you
25	will remain mute and your camera will be

16	Ms. Andrews, can you please elevate				
17	the rights of the parties in this case? Thank				
18	you.				
19	MS. ANDREWS: Sure. Standby.				
20	CHAIRPERSON ANDERSON: So while Ms.				
21	Andrews is elevating the rights, if you are a				
22	party participant for Brick Lane Restaurant,				
23	please identify yourself so Ms. Andrews can				
24	elevate your rights so you can participate in				
25	this hearing.				

1	MS. ANDREWS: Mr. Ruiz, your rights		
2	have been elevated. That's all I have for now,		
3	Mr. Chair.		
4	CHAIRPERSON ANDERSON: If you're Mr.		
5	Elalami, E-L-A-L-A-M-I. What about Mr.		
6	Karrakchou. Are you on the line? If you are on		
7	the line, either by a video or call in, can you		
8	please identify yourself for the hearing please?		
9	This matter was scheduled for fact-		
10	finding hearing at 1:30, it is now 1:40. So		
11	we're going to wait another five minutes for the		
12	licensee for this case to identify themself.		
13	Maximum five minutes for the licensee to identify		
14	themselves.		
15	Again, if there is anyone online who		
16	is familiar or who's here for Brick Lane		
17	Restaurant license, Brick Lane Restaurant is at		
18	517 8th Street Southeast. The License Number is		
19	109778. Brick Lane Restaurant.		
20	Brick Lane Restaurant, if you are		
21	there, can you please identify yourself?		
22	I'm going to wait two more minutes,		
23	but that's it, we're going to have this hearing		
24	today for them. Going to wait another two more		
25	minutes, to once again, to make sure that no one

1 is there, to move forward. 2 MEMBER GRANDIS: Mr. Chairman? 3 CHAIRPERSON ANDERSON: Yes, Mr. Grandis. 4 5 MEMBER GRANDIS: Thank you. For the record, since this is a public hearing, could we 6 7 put in the record how the owner of record, or 8 owners of record, were notified? 9 CHAIRPERSON ANDERSON: I'm trying to 10 find that information, Mr. Grandis, that's why 11 I'm giving --12 MEMBER GRANDIS: Thank you very much. 13 I just thought it would help with the record. 14 Thank you. 15 CHAIRPERSON ANDERSON: Thank you. As 16 you know, we are all remote so I am trying to get 17 that information. 18 All right. The Licensee was invited 19 with, was provided notice for this hearing on 20 July 28th. 21 I am aware that the Agency has had 22 contact with this Licensee or with this Licensee 23 consistently through its mode of communication, 24 and so they were notified off this hearing on 25 July 28th. And they're not here today. So we're

going to have this fact-finding hearing. 1 2 All right. So, Mr. Ruiz, can you 3 please spell and state your name for the record 4 please? 5 MR. RUIZ: Yes. First name is Mark, M-A-R-K, last name is Ruiz, R-U-I-Z. 6 7 CHAIRPERSON ANDERSON: I apologize, 8 Mr. Ruiz. 9 MR. RUIZ: That's okay. CHAIRPERSON ANDERSON: And where are 10 11 you currently employed? 12 MR. RUIZ: The Alcoholic Beverage 13 Regulation Administration. 14 CHAIRPERSON ANDERSON: And what is 15 your role at the Agency, sir? 16 MR. RUIZ: I am an investigator. 17 CHAIRPERSON ANDERSON: How long have 18 you been working for the Agency, sir? 19 MR. RUIZ: Approximately two and a 20 half years. 21 CHAIRPERSON ANDERSON: And how are you 22 familiar with this, with this establishment, Brick Lane Restaurant? 23 24 MR. RUIZ: Brick Lane became, started 25 investigating the ownership after I had

1	discovered trade name change prior to that. So			
2	in talks with the claimed owners of the property,			
3	the new owners of the property, Ms. Siham Zouine,			
4	and Mr. Mohamad Karrakchou, I have been in			
5	conversation with them since about October 20, 21			
6	when we initially discovered the name change on			
7	the front of the building.			
8	CHAIRPERSON ANDERSON: Hold on, Mr.			
9	Ruiz. Can you spell, you just put two names in			
10	the record, can you spell those names, please,			
11	for the record?			
12	MR. RUIZ: Yes. Mohamed, M-O-H-A-M-E-			
13	D, last name is Karrakchou, K-A-R-R-A-K-C-H-O-U.			
14	And Ms. Siham, S-I-H-A-M, last name Zouine, Z-O-			
15	U-I-N-E.			
16	CHAIRPERSON ANDERSON: Now, how is it			
17	that you have been, what modes of communication			
18	have you been using to communicate with these			
19	individuals?			
20	MR. RUIZ: I have spoke to both of			
21	these individuals in person during the subsequent			
22	visits of the establishment. On April 8th, 2021			
23	when I discovered the trade name had not been			
24	changed since they had taken over ownership.			
25	CHAIRPERSON ANDERSON: Now let me,			
	n

let's start at the beginning. Did you write a 1 2 report? 3 MR. RUIZ: I did. CHAIRPERSON ANDERSON: All right. 4 So 5 why don't you go through your report and tell us what it is that you have, what did you come 6 7 across as far as this establishment is concerned, 8 please? 9 MR. RUIZ: Okay. So, on April 8th, 2021 I had made a visit to the establishment in 10 11 regard to the trade name on the building. The 12 trade name was called Mekki, M-E-K-K-I, which was 13 on a banner sign as well as the menus posted out 14 in front of the building. But the license was 15 still registered as Brick Lane Restaurant. 16 I spoke to a Siham Zouine that day, in 17 which she presented herself as the owner. And 18 her partner, who takes care of the paperwork, was 19 overseas at the time so I could not speak to him 20 at that moment. 21 After returning to the office I 22 conducted a records through Excel program, which 23 established the current owner as Elalami, E-L-A-24 L-A-M-I, last name Ikhiar, I-K-H-I-A-R, listed as 25 the managing member 100 percent. Was the sole

I did attempt to reach Mr. Ikhiar via 1 owner. 2 telephone but I was unsuccessful. 3 I was able to revisit the location on 4 June 24th, 2021 where I was able to meet with the 5 additional partner, Mr. Karrakchou, to get a 6 further understanding of what was going on with 7 the business at the time. At that time the Mekki 8 banner was removed, but they were still operating 9 with menus still stating Mekki. I spoke with Mr. Karrakchou and asked 10 11 him who the owner of the establishment is. And 12 he stated that he was. I then asked him when he 13 acquired the business. He stated he acquired the 14 business February 2020. 15 At which time they began experimenting with the trade name, which he identified as a 16 17 pop-up by the name of Mekki. And he wanted to test out how the menu would work. 18 19 I did ask him about the previous 20 owner, Mr. Ikhiar, which they do have a close 21 friendship relationship. He stated to me that 22 Mr. Ikhiar has been back in his home country overseas and he has no intention to return back 23 24 to the United States. 25 So I notified Mr. Karrakchou that they

needed to get in contact with ABRA. He stated he's been in contact with licensing and legal and showed me the email from Mr. Ikhiar's account. He stated that he obtained the email when they acquired the, took over ownership of the business.

7 I did advise me at that time that they
8 were in violation for change of ownership without
9 Board approval. And I advised him that he make a
10 urgent attempt to contact ABRA and to get all
11 that straightened out.

And on June 28th, 2021 I did check 12 13 with legal, as well as Excel, and there was no 14 indication at that time that an application was 15 made for either a change of ownership or a change The establishment does have a 16 of the trade name. 17 settlement agreement but does not have a security 18 plan. And that's basically the conclusion of my 19 investigation.

20 CHAIRPERSON ANDERSON: So, as far as 21 ABRA is concerned, who is the owner of this 22 establishment?

23 MR. RUIZ: Mr. Ikhiar. I-K-H-I-A-R.
24 From LLC.

CHAIRPERSON ANDERSON: Does ABRA have

any information, is Mr. Ikhiar, is he a 100 1 percent owner of the establishment? 2 3 MR. RUIZ: My review of Excel in the records, was at the time, my check. June 28th. 4 5 CHAIRPERSON ANDERSON: I'm sorry, when? 6 7 MR. RUIZ: June 28th was the last time I checked the record. 8 9 (Simultaneously speaking.) 10 CHAIRPERSON ANDERSON: Go ahead, sir. 11 MR. RUIZ: But I have heard recently 12 that they were contact with licensing and legal 13 for the trade name change. 14 CHAIRPERSON ANDERSON: Do you know the 15 nature of the contact with legal? Are you aware? 16 Or licensing division, are you aware of the, what contact, if any, was made? 17 18 MR. RUIZ: I am not of the details, I 19 just know that they had reached, made an 20 application. 21 CHAIRPERSON ANDERSON: Okay. All 22 I just want the record to reflect that right. 23 service was effectuated, in person, for this 24 hearing on July 23rd. And Mr. Ali, A-L-I, K-H-A-25 L-E-D, Khaled, he signed the service form. So I

want the record to reflect that the personal 1 service was made on July 30th and that Mr. Ali 2 3 Khaled signed the form acknowledging receipt and 4 notice of today's hearing. 5 And it is 1:55, for a 1:30 hearing, and no one has identified themself as a 6 representative from this establishment during the 7 8 question and answer features. So I want the 9 record to reflect that. 10 Are there any questions by any Board 11 Members of Mr. Ruiz? 12 MEMBER SHORT: Yes, Mr. Chair, I had 13 one question for Mr. Ruiz. 14 CHAIRPERSON ANDERSON: Yes, go ahead. 15 MEMBER SHORT: Investigator Ruiz, 16 thank you for your report. I would like to know, 17 on the date or day that you were there and talked 18 to both the prior owner and the one who claimed 19 to be owner now. There were two separate 20 persons, is that correct? 21 No, I have never spoke to MR. RUIZ: 22 the original owner. I was unable to get in contact with them. 23 24 I was, I had spoke to, originally, 25 just a female owner by the last name Zouine, Z-O-

And then I spoke with Karrakchou on two 1 U-I-N-E. 2 different days. So I had one, one day, one the 3 other day. 4 MEMBER SHORT: Okay. So you have 5 talked to how many people all in total that claim they were owners or part owners of this business? 6 7 MR. RUIZ: Two. 8 MEMBER SHORT: And what dates would 9 that have been? 10 MR. RUIZ: One on April 8th, 2021 and 11 June 24th, 2021. 12 MEMBER SHORT: And at that time they 13 said they were going to get it straightened out 14 with ABRA and get the license correctly placed 15 like it should be? 16 MR. RUIZ: Yes. 17 MEMBER SHORT: Thank you very much for 18 your testimony. And thank you, Mr. Chair, that's 19 all I have right now. 20 CHAIRPERSON ANDERSON: Thank you, Mr. 21 Are there any questions by any other Short. 22 Board Members? 23 MEMBER GRANDIS: Yes, sir. 24 CHAIRPERSON ANDERSON: Go ahead, Mr. 25 Grandis.

Thank you. Mr. Ruiz, 1 MEMBER GRANDIS: 2 I want to thank you for your expert testimony 3 today and your participation. Thank you very 4 much. I know you've had long hours and we 5 appreciate your participation. It helps us forming our decision. 6 7 I just want to be clear, for myself. 8 ABRA only recognizes one individual as the owner 9 of this license, is that correct? 10 MR. RUIZ: Correct. One managing 11 member, yes. 12 MEMBER GRANDIS: Yes. So there is no 13 original owner and new owner, there is just, from 14 ABRA's perspective, there is just a managing 15 member of an LLC I'm assuming who is the sole 16 person in ABRA records that indicate that that 17 person is the owner? 18 MR. RUIZ: Correct. 19 MEMBER GRANDIS: And it's my 20 understanding that this fact-finding instructs 21 that the owner, or the owner's representative, to 22 attend this fact-finding today? 23 MR. RUIZ: It's my understanding as 24 well. 25 MEMBER GRANDIS: When you said you,

and I think you've answered this, but when you 1 2 researched the records, you presented testimony 3 that stated that the person purporting to be 4 managing/whatever, with the pop-ups and whatever, 5 said that the owner of record has left the U.S. and gone back to his home country, if I heard 6 7 that correctly? 8 MR. RUIZ: Yes, that's correct. 9 MEMBER GRANDIS: Is there anything in ABRA records that indicates that this owner has 10 11 contacted ABRA to update and change the address 12 for notification? 13 MR. RUIZ: No. 14 MEMBER GRANDIS: And may I ask you if 15 you have, what is the last date that you checked 16 that? 17 The last time I checked the MR. RUIZ: 18 records was on June 28th, 2021. 19 MEMBER GRANDIS: Thank you, I have no 20 more questions. Thank you, Mr. Chairman. 21 CHAIRPERSON ANDERSON: Thank you, Mr. 22 Grandis. Any questions by any other Board 23 Members? 24 All right, hearing none, thank you for 25 your presentation today, Mr. Ruiz.
