The first case is Kidist Lounge, Case No. 23-PRO-5 00068, Kidy Lounge, LLC, 5503 Georgia Avenue NW, 6 7 License No. ABRA-119361. This is a Retailer 8 Class CR for a substantial change for an 9 entertainment endorsement, expansion of premises, change of license class from restaurant to 10 11 tavern. 12 My name is LaVerne Fletcher conducting 13 the roll call hearing as the Board's agent. would like to first acknowledge the presence of 14 15 the Amharic interpreter in this case. 16 Sir, if you would state your name and 17 spell it for the record, please. 18 MR. TEKLE: Good morning. Habtom 19 Tekle, H-A-B-T-O-M T-E-K-L-E, Amharic 20 interpreter. 21 MS. FLETCHER: Yes. Can you pronounce 2.2 your last name again? 23 MR. TEKLE: Tekle. 2.4 MS. FLETCHER: Thank you. Mr. Tekle, 25 you are going to be interpreting for the

4	introduce themselves first.
5	Who is present from Kidist Lounge?
6	MR. BELETE: Ayele Belay Belete, A-Y-

8	MS. FLETCHER: Excuse me. Can you
9	spell it a little slower for me? You said A-Y.
10	MR. BELETE: A-Y-E-L-E, first name.
11	Last name is B-E-L-E-T-E.
12	MS. FLETCHER: Can you spell the last
13	name one more time? What is the first letter?
14	Did you say B as in boy?
15	MR. BELETE: Yes. B-E-L-E-T-E.
16	MS. FLETCHER: I'm going to tell you

1 I'm checking to see if the Protestant is present. 2 The Protestant in this case is not present at the moment so I'm going to allow about 3 four more minutes until 10:15 for the Protestant 4 5 to arrive. I should add that the protest issues 6 7 in this case are adverse impact on peace, order, 8 and quiet. What I'm going to do is call the next 9 case, and then I'm going to recall this one. Any questions about that? 10 11 MR. BELETE: No questions. 12 MS. FLETCHER: Okay. Thank you. 13 (Whereupon, the above-entitled matter went off the record at 10:13 a.m. and resumed at 11:15 14 15 a.m.) 16 MS. FLETCHER: I am recalling Kidist The Protestant in this matter is ANC 4D. 17 18 There is no one present on behalf of ANC 4D. 19 Therefore, the protest is dismissed. A Board 20 order will be issued dismissing the protest 21 because no one is present today from the ANC. 2.2 Mr. Belete and Ms. Shay, you will receive a copy of the Board order. If ANC 4D 23 2.4 seeks reinstatement of the protest, you will be

notified. And you will have an opportunity to

respond and you may say why you believe the protest should be reinstated or not.

If you are not in agreement with the protest, you will have an opportunity to inform the Board of the reason that you're not in agreement with the reinstatement. Are there any questions so far?

MR. BELETE: How long will it take for the Board order to get to us? For a copy of the Board order to get to us?

MS. FLETCHER: The ABC Board meets on Wednesdays. Just one second. They are going to be in recess. Let me check the dates for you. The Board is going to be in recess beginning on the 23rd of August. That's this coming Wednesday.

They are going to be in recess from the 23rd until September the 13th, but there is still a possibility that the Board will respond to the request for reinstatement during this period of time.

The other thing that you should know is that the Protestant will have 10 days upon receipt of the Board order to ask for reinstatement. The Board order may very well be

1 prepared this coming Wednesday. I'm not positive 2 about that at this moment and we'll have to 3 check. So the Applicant will have 10 days to 4 5 ask for reinstatement of the protest upon receipt of the Board order. If they seek reinstatement, 6 7 you'll be notified right away and you will have 8 an opportunity to respond. 9 I cannot be more specific about the time frames at this time because the Board will 10 11 be in recess, but I will find out for you later 12 today whether or not the Board order will be 13 issued this coming Wednesday. Any questions about that? 14 15 MR. BELETE: No questions. 16 MS. FLETCHER: Okay. Well, in that 17 case, the time is now approximately 10:25 and ANC 18 4D still has not appeared. If there are no other 19 questions, then I am going to conclude the roll 20 call hearing. 21 MR. BELETE: I don't have any 2.2 questions. 23 Well, thank you very MS. FLETCHER: 2.4 much for coming and we'll keep you posted.
