3 CHAIRPERSON ANDERSON: We're at the  
4 end of our morning calendar. So, I am now going  
5 to do our legal agenda.

7 is review of an offer in compromise in lieu of a  
8 hearing, dated August 19, 2022, for Case No. 21-  
9 CIT-00020, Safeway, License No. 097701. The  
10 offer in compromise -- and the terms: failing to  
11 have the establishment's owner or Board-approved  
12 ABC manager present during the sales, service,  
13 and consumption of -- sales, service, and  
14 consumption of alcohol. Statutory authority: DC  
15 Code Section 25-701 and 23 DCMR Section 717.1,  
16 defining that \$250 fine paid within 60 days or  
17 the license will be suspended indefinitely.
