3 CHAIRPERSON ANDERSON: Good morning,
4 everyone. We are on the record. I am
5 Chairperson of the Alcoholic Beverage Control
6 Board for the District of Columbia, and in
7 accordance with D.C. Official Code Section 2576
8 of the Open Meetings Act I am welcoming you to
9 the regularly scheduled meeting of the Alcoholic
10 Beverage Control Board.

11 This meeting is being conducted
12 pursuant to guidance made available by the
13 District of Columbia's Office of Open Government
14 regarding electronic meetings held by public
15 bodies during the public emergency. Pursuant to
16 this guidance notice of today's meeting was

2 My name is Donovan Anderson, I am
3 Chairman of the Board. I would like to introduce
4 the other members of the ABC Board who are also
5 participating electronically pursuant to Mayor's
6 Order 2021-096. Please respond when I announce
7 your name. Mr. James Short.

8 MEMBER SHORT: Mr. James Short
9 present.

10 CHAIRPERSON ANDERSON: Ms. Jeni
11 Hansen.

12 MEMBER HANSEN: Jeni Hansen present.

13 CHAIRPERSON ANDERSON: Mr. Edward
14 Grandis.

15 MEMBER GRANDIS: Edward Grandis
16 present.

17 CHAIRPERSON ANDERSON: The Board has
18 four members in attendance for the conduct of
19 business, and this constitutes a quorum. Before
20 getting underway with today's hearing I need to
21 make a few instructions very clear. We do not
22 have a calendar today, we just have a legal
23 agenda - I'm sorry, a licensing agenda, three
24 licensing agendas that we will participate in
25 today, so there are no hearings for the public to

1 participate, but if anyone is online and have

7 We just have three licensing agenda
8 items, and the first - so we are going to turn
9 to our licensing agenda, and the first matter on
10 the licensing agenda, the review or request for
11 disposal permit to transport remaining alcoholic
12 beverage products as a result of license
13 cancellation to the MPE Hotel I (Washington) LLC,
14 trade name Ritz-Carlton Hotel located at 2200 M
15 Street, NW. Their License Number is 060273. The
16 request has been made by The Fairfax at Embassy
17 Row, License Number 102830. I make a motion that
18 we approve this request. Is there a second?

19 D.C. Capital Square Bar & Grill, License Number
20 118000. They are a Retailer C restaurant, new
21 ABC license application.

22 The next request, a request made by
23 Rose's at Home, License Number 114310. This is a
24 letter of request to transfer license to a new
25 location.

1 The next request, a request made,
2 trade name Sankofa Caf,, License Number 118499.
3 They are a Retailer C tavern, new ABC license
4 application.

5 The next request, a request made by
6 Caf, Vino, License Number 118904, Retailer C
7 restaurant, transfer without sale application.

8 The next request is a request made
9 from 100 Proof Spirits. The License Number
10 118418. They are Internet Retailer A. This is a
11 new ABC license application.

12 The next request, a request made by
13 Canopy-Embassy Row/Super Franc, License Number
14 071165. They are a Retailer C hotel, change of
15 ownership interest application.

16 The next request is a request made by
17 Mosaico by Arepa Zone, License Number 118307.
18 They are a Retailer C tavern with ABC license
19 application.

20 The next request, a request made by
21 Songbyrd, License Number 119107. They are a
22 Retailer C restaurant transfer with sale
23 application.

24 The last request is a request made by
25 Enid Silva LLC, trade name to be determined,

1 License Number 119383. They are a caterer, new
2 ABC license application.

3 I then make a motion that ABC Board
4 approve all these requests. Is there a second?

5 MEMBER GRANDIS: Ed Grandis, approve.
