11 category that allows licensed on-premises  
12 retailers to apply for a one day substantial  
13 change for the Open Streets DC event that has  
14 been designated by the Mayor at the special event  
15 areas.

16 Specifically, the new license category  
17 allows on-street premises retailers to add or  
18 expand on the existing exterior license base in  
19 order to participate in the District of Columbia  
20 Open Streets DC event.

21 Mayor's Order 2022-117, dated July 26,  
22 2022, authorizes licensed food establishments  
23 with a physical address on Georgia Avenue  
24 Northwest in Wards 1 and 4 to expand their  
25 footprint of services on the sidewalk and street

1 immediately in front of the establishment on  
2 October 1, 2022, with no additional fees imposed  
3 by the Department of Consumer Regulatory Affairs  
4 or the Alcoholic Beverage Control Administration.  
5 An additional Open Streets DC event is planned  
6 for Ward 3 by mid-November 2022.

7 DC Code Section 25502 authorizes the  
8 Mayor to create the additional license category.  
9 DC Code Section 2506(c) authorizes the Board by  
10 regulation to permit unpermitted retailers to  
11 expand their exterior space in order to  
12 facilitate the creation of a community street  
13 festival up to twice year in a calendar year.

14 Based upon this authority, the Board  
15 has created a new Open Streets license category.  
16 The Board is implementing these rules on an  
17 emergency basis for two reasons.

18 First, the emergency rules will allow  
19 unpermitted retailers to participate in scheduled  
20 upcoming Open Streets DC events.

21 Second, encourage participation in the  
22 District's Open Streets DC program by temporarily  
23 closing streets and allow for activities suitable  
24 for all ages and abilities, and inspire people to  
25 think differently about their streets by



1 encouraging physical activity, creating  
2 recreational activities, and fostering community-  
3 building and dedication.

4 I make a motion that the Board approve
